LONG TITLE

Committee Note:

The Law Enforcement and Criminal Justice Interim Committee recommended this bill.

Legislative Vote: 9 voting for 0 voting against 7 absent

General Description:

This bill modifies provisions related to offenses committed by inmates.

Highlighted Provisions:

This bill:

- ▶ adds and removes certain crimes from the list of offenses that qualify certain inmates to be sentenced to life in prison without the possibility of parole; and
- ▶ makes conforming changes.

Be it enacted by the Legislature of the state of Utah:



28 Section 1. Section **76-3-203.6** is amended to read:

29 **76-3-203.6. Enhanced penalty for certain offenses committed by prisoner.**

30 (1) As used in this section, "serving a sentence" means a prisoner is sentenced and
31 committed to the custody of the Department of Corrections, the sentence has not been
32 terminated or voided, and the prisoner:

- 33 (a) has not been paroled; or
- 34 (b) is in custody after arrest for a parole violation.

35 (2) If [~~the trier of fact finds beyond a reasonable doubt that~~] a prisoner serving a
36 sentence for a capital felony or a first degree felony commits any offense listed in Subsection
37 (5), the offense is a first degree felony and the court shall sentence the defendant to life in
38 prison without parole.

39 (3) Notwithstanding Subsection (2), the court may sentence the defendant to an
40 indeterminate prison term of not less than 20 years and that may be for life if the court finds
41 that the interests of justice would best be served and states the specific circumstances justifying
42 the disposition on the record.

43 (4) Subsection (2) does not apply if the prisoner is younger than 18 years of age at the
44 time the offense listed in Subsection (5) is committed and is sentenced on or after May 10,
45 2016.

- 56 (i) object rape, Section 76-5-402.2;
- 57 (j) object rape of a child, Section 76-5-402.3;
- 58 (k) forcible sodomy, Section 76-5-403;

- 59 (l) sodomy on a child, Section 76-5-403.1;
- 60 (m) aggravated sexual abuse of a child, Section 76-5-404.1;
- 61 (n) aggravated sexual assault, Section 76-5-405;
- 62 (o) aggravated arson, Section 76-6-103;
- 63 (p) aggravated burglary, Section 76-6-203; and

- 65 (6) The sentencing enhancement described in this section does not apply if:
- 66 (a) the offense for which the person is being sentenced is:
- 67 (i) a grievous sexual offense;
- 68 (ii) child kidnapping, Section 76-5-301.1; or
- 69 (iii) aggravated kidnapping, Section 76-5-302; and
- 70 (b) applying the sentencing enhancement provided for in this section would result in a
- 71 lower maximum penalty than the penalty provided for under the section that describes the
- 72 offense for which the person is being sentenced.

73 Section 2. Section 76-5-103.5 is amended to read:

74 **76-5-103.5. Aggravated assault by prisoner.**

75 Any prisoner who commits aggravated assault [~~not amounting to a violation of Section~~
76 ~~76-3-203.6~~] is guilty of:

- 77 (1) a second degree felony if no serious bodily injury was intentionally caused; or
- 78 (2) a first degree felony if serious bodily injury was intentionally caused.
