**LONG TITLE**

**General Description:**

This bill modifies provisions relating to gambling.

**Highlighted Provisions:**

This bill:

- ▶ defines terms;
- ▶ modifies the crime of gambling;
- ▶ prohibits placing a fringe gaming machine into operation;
- ▶ authorizes a municipality and county to seize gambling debts, proceeds, or a fringe gaming device under certain circumstances; and
- ▶ makes technical and conforming changes.

37           Section 1. Section **32B-3-303** is amended to read:

38           **32B-3-303. Acts making a person subject to this part.**

39           (1) One or more of the following acts constitute a nuisance activity:

40           (a) a single felony conviction within the last two years of:

41           (i) a retail licensee; or

42           (ii) supervisory or managerial level staff of the retail licensee;

43           (b) a single conviction under Title 58, Chapter 37, Utah Controlled Substances Act:

44           (i) (A) of a retail licensee; or

45           (B) staff of the retail licensee;

46           (ii) within the last two years; and

47           (iii) made on the basis of an act that occurs on the licensed premises;

48           (c) three or more convictions of patrons of a retail licensee under Title 58, Chapter 37,

96 (1) (a) A retail licensee and staff of a retail licensee shall comply with this title and the

97 rules of the commission, including the relevant part under Chapter 6, Specific Retail License

98 Act, for the specific type of retail license.

99 (b) Failure to comply as provided in Subsection (1)(a) may result in disciplinary action

100 in accordance with Chapter 3, Disciplinary Actions and Enforcement Act, against:

- 101 (i) a retail licensee;
- 102 (ii) individual staff of a retail licensee; or
- 103 (iii) both a retail licensee and staff of the retail licensee.

104 (2) (a) If there is a conflict between this part and the relevant part under Chapter 6,

142 (5) A retail licensee may not knowingly allow a person on the licensed premises to, in  
143 violation of Title 58, Chapter 37, Utah Controlled Substances Act, or Chapter 37a, Utah Drug  
144 Paraphernalia Act:

145 (a) sell, distribute, possess, or use a controlled substance, as defined in Section  
146 [58-37-2](#); or

147 (b) use, deliver, or possess with the intent to deliver drug paraphernalia, as defined in  
148 Section [58-37a-3](#).

149 (6) Upon the presentation of credentials, at any time during which a retail licensee is  
150 open for the transaction of business, the retail licensee shall immediately:

151 (a) admit a commissioner, authorized department employee, or law enforcement officer  
152 to the retail licensee's premises; and

153 (b) permit, without hindrance or delay, the person described in Subsection (6)(a) to  
154 inspect completely:

155 (i) the entire premises of the retail licensee; and

156 (ii) the records of the retail licensee.

157 (7) An individual may not consume an alcoholic product on the licensed premises of a  
158 retail licensee on any day during the period:

159 (a) beginning one hour after the time of day that the period during which a retail  
160 licensee may not sell, offer for sale, or furnish an alcoholic product on the licensed premises  
161 begins; and

162 (b) ending at the time specified in the relevant part under Chapter 6, Specific Retail

169 Section 3. Section **32B-9-204** is amended to read:

170 **32B-9-204. General operational requirements for an event permit.**

171 (1) (a) An event permittee and a person involved in the storage, sale, offer for sale, or  
172 furnishing of an alcoholic product at an event for which an event permit is issued, shall comply  
173 with this title and rules of the commission.

174 (b) Failure to comply as provided in Subsection (1)(a):

175 (i) may result in:

176 (A) disciplinary action in accordance with Chapter 3, Disciplinary Actions and  
177 Enforcement Act, against:

178 (I) an event permittee;

179 (II) a person involved in the storage, sale, offer for sale, or furnishing of an alcoholic

180 product at the event; or

181 (III) any combination of the persons listed in this Subsection (1)(b);

182 (B) immediate revocation of the event permit;

183 (C) forfeiture of a bond; or

184 (D) immediate seizure of an alcoholic product present at the event; and

185 (ii) if the event permit is revoked, disqualifies the event permittee from applying for an  
186 event permit for a period of three years from the date of revocation of the event permit.

187 (c) An alcoholic product seized under this Subsection (1) shall be returned to the event  
188 permittee after an event if forfeiture proceedings are not instituted under Section [32B-4-206](#).

189 (2) (a) If there is a conflict between this part and the relevant part under this chapter for  
190 the specific type of special use permit held by the special use permittee, the relevant part  
191 governs.

192 (b) Notwithstanding that this part may refer to "liquor" or an "alcoholic product," an  
193 event permittee may only sell, offer for sale, or furnish an alcoholic product specified in the  
194 relevant part under this chapter for the type of event permit that is held by the event permittee.

195 (c) Notwithstanding that this part or the relevant part under this chapter for the type of  
196 event permit held by an event permittee refers to "event permittee," a person involved in the  
197 storage, sale, offer for sale, or furnishing of an alcoholic product at the event for which the  
198 event permit is issued is subject to the same requirement or prohibition.

199 (3) An event permittee shall display a copy of the event permit in a prominent place in  
200 the area in which an alcoholic product is sold, offered for sale, furnished, and consumed.

201 (4) An event permittee may not on the premises of the event:

202 (a) engage in or allow any form of gambling~~[, as defined and proscribed in Title 76,~~  
203 ~~Chapter 10, Part 11, Gambling], as defined in Section [76-10-1101](#), or fringe gambling, as~~

216 58-37-2; or

217 (b) use, deliver, or possess with the intent to deliver drug paraphernalia, as defined in  
218 Section 58-37a-3.

219 (6) An event permittee may not sell, offer for sale, or furnish beer except beer  
220 purchases from:

221 (a) a beer wholesaler licensee;

222 (b) a beer retailer; or

223 (c) a small brewer.

224 (7) An event permittee may not store, sell, offer for sale, furnish, or allow the  
225 consumption of an alcoholic product purchased for an event in a location other than that  
226 described in the application and designated on the event permit unless the event permittee first  
227 applies for and receives approval from the director, with the approval of the Compliance,  
228 Licensing, and Enforcement Subcommittee, for a change of location.

229 (8) (a) Subject to Subsection (8)(b), an event permittee may sell, offer for sale, or  
230 furnish beer for on-premise consumption:

231 (i) in an open original container; and

232 (ii) in a container on draft.

233 (b) An event permittee may not sell, offer for sale, or furnish beer sold pursuant to  
234 Subsection (8)(a):

235 (i) in a size of container that exceeds two liters; or

236 (ii) to an individual patron in a size of container that exceeds one liter.

237 (9) (a) An event permittee may not sell or offer for sale an alcoholic product at less  
238 than the cost of the alcoholic product to the event permittee.

239 (b) An event permittee may not sell an alcoholic product at a discount price on any date  
240 or at any time.

241 (c) An event permittee may not sell or offer for sale an alcoholic product at a price that

242 encourages overconsumption or intoxication.

243 (d) An event permittee may not sell or offer for sale an alcoholic product at a special or  
244 reduced price for only certain hours of the day of an event.

245 (e) An event permittee may not sell, offer for sale, or furnish more than one alcoholic  
246 product at the price of a single alcoholic product.

247 (f) An event permittee, or a person operating, selling, offering, or furnishing an  
248 alcoholic product under an event permit, may not sell, offer for sale, or furnish an indefinite or  
249 unlimited number of alcoholic products during a set period for a fixed price, unless:

250 (i) the alcoholic product is served to a patron at a seated event;

251 (ii) food is available whenever the alcoholic product is sold, offered for sale, or  
252 furnished; and

253 (iii) no person advertises that at the event a person may be sold or furnished an  
254 indefinite or unlimited number of alcoholic products during a set period for a fixed price.

255 (g) An event permittee may not engage in a public promotion involving or offering a  
256 free alcoholic product to the general public.

257 (10) An event permittee may not sell, offer for sale, or furnish an alcoholic product to:

258 (a) a minor;

259 (b) a person actually, apparently, or obviously intoxicated;

260 (c) a known interdicted person; or

261 (d) a known habitual drunkard.

262 (11) (a) An alcoholic product is considered under the control of the event permittee  
263 during an event.

264 (b) A patron at an event may not bring an alcoholic product onto the premises of the  
265 event.

266 (12) An event permittee may not permit a patron to carry from the premises an open  
267 container that:

268 (a) is used primarily for drinking purposes; and

269 (b) contains an alcoholic product.

270 (13) (a) A person involved in the storage, sale, or furnishing of an alcoholic product at  
271 an event is considered under the supervision and direction of the event permittee.

272 (b) A person involved in the sale, offer for sale, or furnishing of an alcoholic product at

273 an event may not, while on duty:

274 (i) consume an alcoholic product; or

275 (ii) be intoxicated.

276 (14) A minor may not handle, sell, offer for sale, or furnish an alcoholic product at an  
277 event.

278 (15) The location specified in an event permit may not be changed without prior  
279 written approval of the commission.

280 (16) An event permittee may not sell, transfer, assign, exchange, barter, give, or  
281 attempt in any way to dispose of the event permit to another person whether for monetary gain  
282 or not.

283 (17) (a) An event permittee may not sell, offer for sale, furnish, or allow the  
284 consumption of an alcoholic product during a period that:

285 (i) begins at 1 a.m.; and

286 (ii) ends at 9:59 a.m.

287 (b) This Subsection (17) does not preclude a local authority from being more restrictive  
288 with respect to the hours of sale, offer for sale, furnishing, or consumption of an alcoholic  
289 product at an event.

290 (18) A patron may have no more than one alcoholic product of any kind at a time  
291 before the patron.

292 (19) (a) An event permittee shall display, in a prominent place, a sign in large letters  
293 that consists of text in the following order:

294 (i) a header that reads: "WARNING";

295 (ii) a warning statement that reads: "Drinking alcoholic beverages during pregnancy  
296 can cause birth defects and permanent brain damage for the child.";

297 (iii) a statement in smaller font that reads: "Call the Utah Department of Health at  
298 [insert most current toll-free number] with questions or for more information.";

299 (iv) a header that reads: "WARNING"; and

308 Section 4. Section **76-10-1101** is amended to read:

309 **76-10-1101. Definitions.**

310 As used in this part:

311 (1) (a) "Amusement device" means a game that:

312 (i) is activated by a coin, token, or other object of consideration or value; and

313 (ii) does not provide the opportunity to:

314 (A) enter into a sweepstakes, lottery, or other gambling event; or

315 (B) receive any form of consideration or value, except an appropriate reward.

316 (b) "Amusement device" includes:

317 (i) a video game;

318 (ii) a driving simulator;

319 (iii) an electronic game;

320 (iv) a claw machine;

321 (v) a bowling game;

322 (vi) a shuffleboard game;

323 (vii) a skee-ball game;

324 (viii) a pool table;

325 (ix) a pinball machine;

326 (x) a target machine; and

327 (xi) a baseball machine.

328 (2) "Amusement facility" means a facility that:

329 (a) is operated primarily for the purpose of providing amusement or entertainment to  
330 customers;

331 (b) is located on property that is open to customers for the purpose of providing  
332 customers with an opportunity to use an amusement device;

333 (c) receives a substantial amount of the facility's revenue from the operation of  
334 amusement devices; and

346 reward for playing; or

347 (D) tickets or credits that are redeemable for a toy, novelty, or non-monetary prize at an  
348 amusement facility, or at any franchise or chain of the amusement facility, where the

350 (b) "Appropriate reward" does not include money, a gift certificate, a gift card, credit to  
351 be used in a retail store, or other form of monetary compensation or reward.

353 (5) "Enter or entry" means an act or process by which an individual becomes eligible to  
354 receive a prize offered for participation in any form of sweepstakes, game, or contest.

355 [(-)] (6) (a) "Fringe gambling" means any de facto form of gambling, lottery, fringe  
356 gaming device, or video gaming device that is given, conducted, or offered for use or sale by a  
357 business in exchange for anything of value or incident to the purchase of another good or  
358 service.

359 (b) "Fringe gambling" does not include:

360 (i) a promotional activity that is clearly ancillary to the primary activity of a  
361 business[-]; or

362 (ii) use of an amusement device, vending machine, or skill-based game.

363 [(-)] (7) (a) "Fringe gaming device" means a [~~device that provides the user~~]  
364 ~~mechanically, electrically, or electronically operated machine or device that:~~

365 (i) is not an amusement device, a vending machine, or skill-based game.

366 (ii) is capable of displaying or otherwise presenting information on a screen or through  
367 any other mechanism; and

415 chance, whether called a lottery, raffle, or gift enterprise, or by whatever name it is known.

416 (15) "Prize" means a gift, award, gratuity, good, service, credit, or anything else of  
417 value that may be or is transferred to an individual or placed on an account or other record with  
418 the intent to be transferred to an individual.

538 derive an economic benefit from a fringe gaming device by:

539 (a) permitting a fringe gaming device to be located on or in any real or personal  
540 property owned, rented, or under the control of the person; or

541 (b) allowing individual or public access or use of a fringe gaming device as part of any  
542 business owned or operated by the person;

543 (c) inducing or aiding a person to use a fringe gaming device;

574 municipality may seize gambling debts, gambling proceeds, or fringe gaming devices that are  
575 reasonably identifiable as being obtained or provided in violation of this part or a local
