LONG TITLE

General Description:

This bill creates the Intensive Services Special Education Pilot Program to provide funding to local education agencies to supplement the cost of educating a student with intensive special education needs.

Highlighted Provisions:

This bill:

▶ creates the Intensive Services Special Education Pilot Program (program) to provide funding to local education agencies to supplement the cost of educating a student who:

- has an Individualized Education Plan (IEP); and
- for whom the cost of the special education services described in the student's IEP exceeds three times the statewide average per-pupil expenditures;

▶ requires the State Board of Education to make rules establishing a distribution formula to allocate money appropriated under the program; and

▶ provides a sunset date.

Money Appropriated in this Bill:

This bill appropriates in Fiscal Year 2022:

▶ to the State Board of Education - Minimum School Program - Related to Basic School Program - Special Education - Intensive Services as a one-time appropriation:

- from the Education Fund, \$1,000,000.

39 Section 1. Section **53F-2-418** is enacted to read:

40 **53F-2-418. Intensive Services Special Education Pilot Program.**

41 (1) As used in this section:

42 (a) "Eligible student" means a student:

43 (i) who has an IEP; and

44 (ii) for whom the cost of special education services described in the student's IEP
45 exceeds three times the statewide average per-pupil expenditures.

46 (b) "Intensive Services Special Education Pilot Program" or "program" means the
47 three-year pilot program created in Subsection (2).

48 (c) "Special education services" means the same as that term is defined in Section
49 53E-7-201.

50 (2) There is created a three-year pilot program known as the Intensive Services Special
51 Education Pilot Program to, subject to appropriations from the Legislature, provide funding to
52 an LEA to supplement the other funding for educating an eligible student.

53 (3) An LEA shall use a distribution under this section to fund special education
54 services for an eligible student.

55 (4) The state board shall, in accordance with Title 63G, Chapter 3, Utah Administrative

56 Rulemaking Act, make rules establishing a distribution formula to allocate money appropriated
57 to the state board under this section to LEAs for the program.

113 Section 3. **Appropriation.**

114 The following sums of money are appropriated for the fiscal year beginning July 1,
115 2021 and ending June 30, 2022. These are additions to amounts previously appropriated for
116 fiscal year 2022. Under the terms and conditions of Title 63J, Chapter 1, Budgetary Procedures
117 Act, the Legislature appropriates the following sums of money from the funds or accounts
118 indicated for the use and support of the government of the state of Utah.
