10                   **General Description:**

11                                   This concurrent resolution recognizes the success of the 2020 election.

12                   **Highlighted Provisions:**

- 14                                   ▶ recognizes Utah's increase in voter turnout in the 2020 election; and
- 15                                   ▶ recognizes the invaluable function that election workers provide to Utah.

19                   *Be it resolved by the Legislature of the state of Utah, the Governor concurring therein:*

20                                   WHEREAS, Utah had over 1.6 million registered voters during the 2020 election;

21                                   WHEREAS, Utah had the highest voter turnout in over 60 years with 90% of active  
22 registered voters casting a ballot in the 2020 election;

23                                   WHEREAS, Utah had the second highest increase in voter turnout in the nation from  
24 2016-2020;

25                                   WHEREAS, over 92% of Utah voters cast a by-mail ballot;

26                                   WHEREAS, every signature of every voter is checked on vote-by-mail ballots by  
27 election officials to safeguard the system against fraud;

28                                   WHEREAS, centralized supervision of ballot processing in county clerks' offices

29 maintains uniformity and strict compliance with laws throughout the state;

30 WHEREAS, elections are the foundation of our democracy and election officials work  
31 tirelessly to protect this critical infrastructure while maintaining public confidence in the  
32 outcome of our electoral processes;

33 WHEREAS, the COVID-19 pandemic has created complexities in the administration of  
34 elections requiring election officials to conduct accurate and timely elections while protecting  
35 the safety of election workers and the voting public:

36 NOW, THEREFORE, BE IT RESOLVED that the Legislature of the state of Utah, the  
37 Governor concurring therein, recognizes the efforts of Utah's county and municipal clerks to  
38 ensure the success of the 2020 election;

39 BE IT FURTHER RESOLVED that the Legislature of the state of Utah, the Governor  
40 concurring therein, extends its appreciation and admiration for the election officials and  
41 workers of this state and the vital services that they perform in conducting this state's elections;

43 BE IT FURTHER RESOLVED that a copy of this resolution be sent to the Utah  
44 Municipal Clerks Association, the Utah County Clerk and Auditor Association, the Utah  
45 League of Cities and Towns, the Utah Association of Counties, and the lieutenant governor's
