Section 1. Section 53B-29-301 is enacted to read:

53B-29-301. Definitions.

As used in this part:

- (1) "{School} Department" means the {School for Civics and Economic} Department of Civic Thought and Leadership.
 - (2) "University" means Utah Valley University.

Section 2. Section **53B-29-302** is enacted to read:
