8	Section 1. Section <b>53G-9-703</b> is amended to read:
9	53G-9-703. Parent education Mental health Bullying Safety.
0	(1) (a) Except as provided in Subsection (3), a school district shall offer a seminar for
1	parents of students in the school district that:
2	(i) is offered at no cost to parents;
3	(ii) (A) begins at or after 6 p.m.; or
1	(B) takes place on a Saturday;
5	(iii) is held in at least one school located in the school district; and
6	(iv) covers the topics described in Subsection (2).
7	(b) (i) A school district shall annually offer one parent seminar for each 11,000
8	students enrolled in the school district.
9	(ii) Notwithstanding Subsection (1)(b)(i), a school district may not be required to offer
0	more than three seminars.
1	(c) A school district may:
2	(i) develop its own curriculum for the seminar described in Subsection (1)(a); or
3	(ii) use the curriculum developed by the state board under Subsection (2).
1	(d) A school district shall notify each charter school located in the attendance
5	boundaries of the school district of the date and time of a parent seminar, so the charter school
6	may inform parents of the seminar.
7	(2) The state board shall:
8	(a) develop a curriculum for the parent seminar described in Subsection (1) that

0	(i) substance abuse, including illegal drugs and prescription drugs and prevention;
1	(ii) bullying;
2	(iii) mental health, depression, suicide awareness, and suicide prevention, including
3	education on limiting access to fatal means;
4	(iv) Internet safety, including pornography addiction; and
5	(v) the SafeUT and Crisis Line established in Section 53B-17-1202; and
6	(b) provide the curriculum, including resources and training, to school districts upon

(3) (a) A school district is not required to offer the parent seminar if the local school
board determines that the topics described in Subsection (2) are not of significant interest or
value to families in the school district.

- (b) If a local school board chooses not to offer the parent seminar, the local school
  board shall notify the state board and provide the reasons why the local school board chose not
  to offer the parent seminar.
- 64 (c) A local school board may provide the parent seminar described in Subsection (1)
   65 through a virtual platform if a local or state public health order restricts public gatherings in the
- 66 school district's geographic area.
