Highlighted Provisions:

This resolution:

- ▶ acknowledges the widespread nature of child sexual abuse ~~{globally, nationally, and at the state level}~~in Utah;
- ▶ explains the impact of child sexual abuse on ~~{victims}~~survivors and communities;
- ▶ encourages discussion about the effects and prevalence of child sexual abuse; and
- ▶ encourages ~~{greater study and }~~discussion about ways in which the government,

communities, and citizens of Utah can prevent child sexual abuse and support those affected.

Be it resolved by the Legislature of the state of Utah:

~~{~~ WHEREAS, the Rape, Abuse and Incest National Network reports that nationally, one in nine girls and one in 53 boys under the age of 18 experience sexual abuse or assault at the hands of an adult;

} WHEREAS, in Utah, it is estimated that one in 10 children will be sexually abused before they turn 18 years old;

WHEREAS, a report on rape in Utah published in 2007 by the Utah Commission on Criminal and Juvenile Justice found that almost 80% of females who had been sexually assaulted reported that their first sexual assault occurred before their 18th birthday;

WHEREAS, ~~{victims}~~ it is estimated that the ramifications of child sexual abuse cost the state of Utah approximately \$1 billion annually;

WHEREAS, survivors of child sexual abuse are about four times more likely to develop symptoms of drug abuse and experience Post Traumatic Stress Disorder as adults;

WHEREAS, ~~{victims}~~ survivors of child sexual abuse are about three times more likely to experience a major depressive episode as adults;

WHEREAS, ~~{victims}~~ survivors of child sexual abuse are ~~{also likely to experience other}~~ at a higher risk of experiencing behavioral health problems, including eating disorders, learning difficulties, ~~{behavioral problems,}~~ fearfulness, social withdrawal, anxiety, and suicidal thoughts;

WHEREAS, ~~{it is estimated that the ramifications}~~ survivors of child sexual abuse ~~{cost the state of Utah approximately \$1 billion annually}~~;

~~—~~ WHEREAS, ~~}~~ are at a higher risk of experiencing poor physical health outcomes across the lifespan, including asthma, cancer, obesity, and heart disease;

WHEREAS, advocacy organizations such as Prevent Child Abuse ~~{America}~~ Utah have indicated that raising awareness of ~~{the unacceptability of}~~ and preventing child sexual abuse is ~~{an important step in prevention,}~~ critical for promoting safe and healthy children and families

WHEREAS, experts have also urged that stopping child sexual abuse is ~~fall~~ ~~citizens'}~~ each adult's responsibility and requires the public to be properly educated on the true nature of abuse~~;~~

WHEREAS, Utah statute requires an individual who has reason to believe a child has been subjected to abuse or neglect, or observes a child being subjected to conditions or circumstances that would reasonably result in abuse or neglect, to report the alleged abuse or neglect to the certain authorities:

NOW, THEREFORE, BE IT RESOLVED that the Legislature of the state of Utah encourages open and frank discussion about the effects and prevalence of child sexual abuse and supports evidence-based solutions to prevent and reduce the harmful impacts of child sexual abuse.

BE IT FURTHER RESOLVED that the ways in which the government, communities, and citizens of Utah can prevent child sexual abuse and best support those affected should be further ~~{studied and }~~ discussed and addressed to ensure that children in Utah are healthy and safe, regardless of race, ethnicity, religion, gender identity, or socioeconomic status.
