8   **LONG TITLE**

9   **General Description:**

10           This concurrent resolution of the Legislature and the Governor honors the life and  
11   contributions of William E. Christoffersen.

12   **Highlighted Provisions:**

13           This resolution:

- 14           ▶ recognizes the life of William E. Christoffersen;
- 15           ▶ honors William E. Christoffersen as a dedicated advocate for veterans both in Utah  
16   and the nation; and
- 17           ▶ commemorates William E. Christoffersen's lifelong service to the American Legion  
18   on both the national and local levels.

22   *Be it resolved by the Legislature of the state of Utah, the Governor concurring therein:*

23           WHEREAS, William E. Christoffersen was born June 6, 1926, and grew up in Cache  
24   County, Utah;

25           WHEREAS, in 1944, Christoffersen joined the United States Army and served in the  
26   Philippines as an infantryman during World War II;

27           WHEREAS, during his military service, Christoffersen was awarded and presented  
28   with the Asiatic Pacific Campaign Medal, the World War II Victory Medal, the Good Conduct  
29   Medal, and the Philippine Independence Ribbon;

30           WHEREAS, upon receipt of an honorable discharge from military service in 1946,  
31 Christoffersen returned home, founded, and successfully managed a construction company in  
32 Logan, Utah;

33           WHEREAS, in 1945, Christoffersen joined the American Legion, one of the nation's  
34 largest veterans service organizations;

35           WHEREAS, in 1957, Christoffersen was elected Utah Department Vice Commander of  
36 the American Legion, and in 1959, Utah Department Commander;

37           WHEREAS, in 1963, his leadership and advocacy on behalf of veterans won him  
38 election to the highest state post representing Utah on the American Legion's National  
39 Executive Committee where he served until 1973, and again from 1975 to 2013;

40           WHEREAS, he remained an active member of the American Legion for 75 years;

41           WHEREAS, Christoffersen was a lifelong advocate for veterans, both in Utah and the  
42 nation;

43           WHEREAS, Christoffersen fought and lobbied in Washington, D.C. for veterans by  
44 meeting with members of Congress, armed forces leadership, and several United States  
45 presidents;

46           WHEREAS, Christoffersen brought three national conventions of the American Legion  
47 and distinguished visitors to Utah, including President George W. Bush in 2006;

48           WHEREAS, Christoffersen was instrumental in establishing the federal Transition  
49 Assistance Program, which provides information, tools, and training to service members and  
50 their families, to help prepare veterans for reintegration into civilian life;

51           WHEREAS, much of the legislation Christoffersen worked on continues to serve as the  
52 basis of policies for the United States Department of Veterans Affairs today;

53           WHEREAS, as a member of the American Legion's National Executive Committee,  
54 Christoffersen made it a goal to see that a veterans home was built in Utah to ensure veterans'  
55 long-term care;

56           WHEREAS, Christoffersen's construction background proved helpful in the realization  
57 of this goal;

58 WHEREAS, in 1998, after 35 years, the Salt Lake Veterans Home opened;

59 WHEREAS, in 2013, the Salt Lake Veterans Home was renamed the William E.  
60 Christoffersen Salt Lake Veterans Home in his honor;

61 WHEREAS, due to complications while battling COVID-19, he passed away on May  
62 31, 2020, in the veterans home that bears his name; and

63 WHEREAS, distinguishing himself through lifelong service and commitment to the  
64 welfare of veterans, Christoffersen exemplified the values of duty and honor to his country:

65 NOW, THEREFORE, BE IT RESOLVED that the Legislature of the state of Utah, the  
66 Governor concurring therein, honors the memory and contributions of William E.  
67 Christoffersen and his legacy as a stalwart advocate for veterans.
