100	making impractical in certain circumstances; or
101	(d) any other factor the court considers relevant including those listed in this section

103	(4) (a) The person who desires joint legal custody shall file a proposed parenting plan
104	in accordance with Sections 30-3-10.8 and 30-3-10.9.
105	(b) A presumption for joint legal custody may be rebutted by a showing by a
106	preponderance of the evidence that it is not in the best interest of the child.
107	(c) A presumption for joint physical custody, where the parenting time is equal or as
108	equal as practicable, may be rebutted by a showing by a preponderance of the evidence that it is

133	whether a substantial change has occurred for the purpose of modifying an award of custody.
134	(b) The court may not consider the disability of a parent as a factor in awarding custody
135	or modifying an award of custody based on a determination of a substantial change in
136	circumstances, unless the court makes specific findings that:
137	(i) the disability significantly or substantially inhibits the parent's ability to provide for
138	the physical and emotional needs of the child at issue; and
139	(ii) the parent with a disability lacks sufficient human, monetary, or other resources
140	available to supplement the parent's ability to provide for the physical and emotional needs of
141	the child at issue.
142	(c) Nothing in this section may be construed to apply to adoption proceedings under
143	Title 78B, Chapter 6, Part 1, Utah Adoption Act.
144	[(7) This section does not establish a preference for either parent solely because of the
145	gender of the parent.]
146	[(8) This section establishes neither a preference nor a presumption for or against joint
147	physical custody or sole physical custody, but allows the court and the family the widest
148	discretion to choose a parenting plan that is in the best interest of the child.]

(7) When awarding custody or modifying an award of custody under Section

150	<u>30-3-10.4</u> , the court may not:
151	(a) discriminate against a parent due to the parent's gender; or
152	(b) use the gender of a parent or child as a factor.
153	[(9)] (8) When an issue before the court involves custodial responsibility in the event
154	of a deployment of one or both parents who are servicemembers, and the servicemember has
155	not yet been notified of deployment, the court shall resolve the issue based on the standards in

157	[(10)] (9) In considering the past conduct and demonstrated moral standards of each

176	order joint legal custody or joint physical custody or both if one or both parents have filed a
177	parenting plan in accordance with Section 30-3-10.8 and the court determines that joint legal
178	custody or joint physical custody or both is in the best interest of the child.
179	(2) In determining whether the best interest of a child will be served by ordering joint
180	legal custody or joint physical custody or both, the court shall consider the custody factors in

181	Section 30-3-10 and the following factors:
182	[(a) whether the physical, psychological, and emotional needs and development of the

234	(2) An order of joint legal or physical custody shall provide terms the court determines
235	appropriate, which may include specifying:
236	(a) either the county of residence of the child, until altered by further order of the court
237	or the custodian who has the sole legal right to determine the residence of the child;
238	(b) that the parents shall exchange information concerning the health, education, and

- (b) A court order modifying or terminating an existing joint legal custody or joint physical custody order shall contain written findings that:
 - (i) a material and substantial change of circumstance has occurred; and
- (ii) a modification of the terms and conditions of the order would be an improvement for and in the best interest of the child.
- (c) The court shall give substantial weight to the existing joint legal custody or joint physical custody order when the child is thriving, happy, and well-adjusted.
- (3) The court shall, in every case regarding a petition for termination of a joint legal custody or joint physical custody order, consider reasonable alternatives to preserve the existing order in accordance with Subsection 30-3-10(3). The court may modify the terms and conditions of the existing order [in accordance with Subsection 30-3-10(8)] and may order the parents to file a parenting plan in accordance with this chapter.
- (4) A parent requesting a modification from sole custody to joint legal custody or joint physical custody or both, or any other type of shared parenting arrangement, shall file and serve a proposed parenting plan with the petition to modify in accordance with Section 30-3-10.8.
- (5) If the court finds that an action under this section is filed or answered frivolously and in a manner designed to harass the other party, the court shall assess attorney fees as costs against the offending party.
- (6) If an issue before the court involves custodial responsibility in the event of deployment of one or both parents who are servicemembers, and the servicemember has not yet been notified of deployment, the court shall resolve the issue based on the standards in Sections

311	(1) Parent-time schedules mutually agreed upon by both parents are preferable to a
312	court-imposed solution.
313	(2) The parent-time schedule shall be used to maximize the continuity and stability of
314	the child's life.
315	(3) Special consideration shall be given by each parent to make the child available to
316	attend family functions including funerals, weddings, family reunions, religious holidays,
317	important ceremonies, and other significant events in the life of the child or in the life of either
318	parent which may inadvertently conflict with the parent-time schedule.
319	(4) The responsibility for the pick up, delivery, and return of the child shall be
320	determined by the court when the parent-time order is entered, and may be changed at any time
321	a subsequent modification is made to the parent-time order.
322	(5) If the noncustodial parent will be providing transportation, the custodial parent
323	shall have the child ready for parent-time at the time the child is to be picked up and shall be
324	present at the custodial home or shall make reasonable alternate arrangements to receive the
325	child at the time the child is returned.
326	(6) If the custodial parent will be transporting the child, the noncustodial parent shall
327	be at the appointed place at the time the noncustodial parent is to receive the child, and have
328	the child ready to be picked up at the appointed time and place, or have made reasonable

330	(7) Regular school hours may not be interrupted for a school-age child for the exercise
331	of parent-time by either parent.
332	(8) The court may make alterations in the parent-time schedule to reasonably

- (9) The court may make alterations in the parent-time schedule to reasonably accommodate the distance between the parties and the expense of exercising parent-time.
- (10) Neither parent-time nor child support is to be withheld due to either parent's failure to comply with a court-ordered parent-time schedule.
- (11) The custodial parent shall notify the noncustodial parent within 24 hours of receiving notice of all significant school, social, sports, and community functions in which the child is participating or being honored, and the noncustodial parent shall be entitled to attend and participate fully.
- (12) The noncustodial parent shall have access directly to all school reports including preschool and daycare reports and medical records and shall be notified immediately by the custodial parent in the event of a medical emergency.
- (13) Each parent shall provide the other with the parent's current address and telephone number, email address, and other virtual parent-time access information within 24 hours of any change.
- (14) Each parent shall permit and encourage, during reasonable hours, reasonable and uncensored communications with the child, in the form of mail privileges and virtual parent-time if the equipment is reasonably available, provided that if the parties cannot agree on whether the equipment is reasonably available, the court shall decide whether the equipment for virtual parent-time is reasonably available, taking into consideration:
 - (a) the best interests of the child;
 - (b) each parent's ability to handle any additional expenses for virtual parent-time; and
 - (c) any other factors the court considers material.
- (15) Parental care shall be presumed to be better care for the child than surrogate care and the court shall encourage the parties to cooperate in allowing the noncustodial parent, if willing and able to transport the children, to provide the child care. Child care arrangements existing during the marriage are preferred as are child care arrangements with nominal or no charge.
- (16) Each parent shall provide all surrogate care providers with the name, current address, and telephone number of the other parent and shall provide the noncustodial parent with the name, current address, and telephone number of all surrogate care providers unless the court for good cause orders otherwise.

- (iv) Weekends include any "snow" days, teacher development days, or other days when school is not scheduled and that are contiguous to the weekend period.
- (c) Holidays include any "snow" days, teacher development days after the children begin the school year, or other days when school is not scheduled, contiguous to the holiday period, and take precedence over the weekend parent-time. Changes may not be made to the regular rotation of the alternating weekend parent-time schedule, however:
- (i) birthdays take precedence over holidays and extended parent-time, except Mother's Day and Father's Day; and
- (ii) birthdays do not take precedence over uninterrupted parent-time if the parent exercising uninterrupted time takes the child away from that parent's residence for the uninterrupted extended parent-time.

- (d) If a holiday falls on a regularly scheduled school day, the noncustodial parent shall be responsible for the child's attendance at school for that school day.
- (e) (i) If a holiday falls on a weekend or on a Friday or Monday and the total holiday period extends beyond that time so that the child is free from school and the parent is free from work, the noncustodial parent shall be entitled to this lengthier holiday period.
- (ii) (A) At the election of the noncustodial parent, parent-time over a scheduled holiday weekend may begin from the time the child's school is regularly dismissed at the beginning of the holiday weekend until 7 p.m. on the last day of the holiday weekend; or

 - (vii) Thanksgiving holiday beginning Wednesday at 7 p.m. until Sunday at 7 p.m.; and
- 489 (viii) the second portion of the Christmas school vacation as defined in Subsection 490 30-3-32(3)(b), beginning 1 p.m. on the day halfway through the holiday period if there are an

odd number of days for the holiday period, or at 7 p.m. if there are an even number of days for the holiday period, so long as the entire Christmas holiday period is equally divided.

- (h) The custodial parent is entitled to the odd year holidays in even years and the even year holidays in odd years.
