**LONG TITLE**

**General Description:**

This bill creates the Kidney Health Task Force.

- ▶ requires the task force to provide recommendations on improving kidney health in Utah; and
- ▶ creates a repeal date.

31 Section 1. Section **36-29-301** is enacted to read:

32 **Part 3. Kidney Health Task Force**

33 **36-29-301. Definitions.**

34 As used in this part, "task force" means the Kidney Health Task Force created in

35 Section [36-29-302](#).

36 Section 2. Section **36-29-302** is enacted to read:

37 **36-29-302. Kidney Health Task Force membership.**

38 (1) There is created the Kidney Health Task Force.

39 (2) The following are members of the task force:

40 (a) a member of the Senate, appointed by the president of the Senate;

41 (b) a member of the Senate, appointed by the minority leader of Senate;

42 (c) a member of the House of Representatives, appointed by the speaker of the House  
43 of Representatives;

44 (d) a member of the House of Representatives, appointed by the minority leader of the  
45 House of Representatives; and

46 (e) the lieutenant governor, or the lieutenant governor's designee.

47 (3) The governor shall appoint the following additional members to the task force:

48 (a) an individual representing the Department of Health and Human Services;

49 (b) an individual representing a health care system;

50 (c) an individual representing the nephrologist community;

51 (d) an individual representing the kidney patient community;

52 (e) two individuals from separate nonprofit organizations that focus on kidney disease;

53 and

54 (f) two individuals who represent any of the following:

55 (i) public health clinics;

56 (ii) community health centers;

57 (iii) minority health organizations; or

58 (iv) private health insurers.

59 (4) (a) A member appointed by the governor under Subsection (3) shall serve a  
60 four-year term.

61 (b) Notwithstanding Subsection (4)(a), for the initial appointments of members  
62 described in Subsection (3), the governor shall appoint four members to a two-year  
63 appointment to ensure that half of the members appointed by the governor rotate every two  
64 years.

65 (c) When a vacancy occurs in the membership for any reason, the applicable appointing  
66 authority shall appoint a replacement for the remainder of the unexpired term of the original  
67 appointment.

68 (5) The Department of Health and Human Services shall provide staff for the task  
69 force.

70 Section 3. Section **36-29-303** is enacted to read:

71 **36-29-303. Task force meetings.**

72 (1) The task force shall annually elect a chair and vice chair from the task force's  
73 membership.

74 (2) The task force shall meet at least four times each year.

75 (3) (a) A majority of the members of the task force constitute a quorum.

76 (b) The action of a majority of a quorum constitutes the action of the task force.

77 Section 4. Section **36-29-304** is enacted to read:

78 **36-29-304. Duties.**

79 (1) The task force shall study issues related to:

80 (a) kidney disease, including higher rates of the disease in minority populations;

81 (b) transplantation; and

82 (c) living and deceased kidney donation.

83 (2) The task force shall provide recommendations for:

84 (a) programs that treat kidney disease;

85 (b) programs that detect kidney disease in early stages of the disease;

86 (c) programs to reduce the burden of kidney disease on patients and communities; and

87 (d) an outreach and marketing campaign that includes:

88 (i) health education workshops and seminars;

89 (ii) preventative screenings;

90 (iii) a social medial campaign; and

91 (iv) television and radio commercials.

92 (3) Before November 1, 2023, and each year thereafter, the task force shall provide a

93 written report to the Health and Human Services Interim Committee regarding the

94 recommendations described in Subsection (2).

95 Section 5. Section **36-29-305** is enacted to read:

96 **36-29-305. Members serve without pay -- Reimbursement for expenses.**

97 (1) A member of the task force who is not a legislator may not receive compensation or

98 benefits for the member's service but may receive per diem and travel expenses as allowed in:

99 (a) Section [63A-3-106](#);

100 (b) Section [63A-3-107](#); and

101 (c) rules made by the Division of Finance according to Sections [63A-3-106](#) and

102 [63A-3-107](#).

103 (2) Salary and expenses of a task force member who is a legislator shall be paid in

104 accordance with Section [36-2-2](#) and Legislative Joint Rules, Title 5, Legislative Compensation

105 and Expenses.
