112 *Be it enacted by the Legislature of the state of Utah:*

113 Section 1. Section **10-3-913** is amended to read:

114 **10-3-913. Authority of chief of police -- Oversight.**

115 (1) The chief of police has the same authority as the sheriff within the boundaries of  
 116 the municipality of appointment. The chief has authority to:

- 117 (a) suppress riots, disturbances, and breaches of the peace;
- 118 (b) apprehend all persons violating state laws or city ordinances;
- 119 (c) diligently discharge his duties and enforce all ordinances of the city to preserve the  
 120 peace, good order, and protection of the rights and property of all persons;

121 (d) attend the municipal justice court located within the city when required, provide  
122 security for the court, and obey its orders and directions; and

123 (e) select a representative of law enforcement to serve as a member of a child  
124 protection team, as defined in Section [~~62A-4a-101~~] [80-1-102](#).

125 (2) This section is not a limitation of a police chief's statewide authority as otherwise  
126 provided by law.

127 (3) The chief of police shall adopt a written policy that prohibits the stopping,  
128 detention, or search of any person when the action is solely motivated by considerations of  
129 race, color, ethnicity, age, or gender.

130 (4) (a) Notwithstanding Sections [10-3-918](#) and [10-3-919](#), a municipality may not  
131 establish a board, committee, or other entity that:

132 (i) has authority independent of the chief of police; and

133 (ii) (A) has authority to overrule a hiring or appointment proposal of the chief of  
134 police;

135 (B) is required to review or approve a police department's rules, regulations, policies,  
136 or procedures in order for the rules, regulations, policies, or procedures to take effect;

137 (C) has authority to veto a new policy, or strike down an existing policy, established  
138 under the authority of the chief of police;

139 (D) is required to review or approve a police department's budget in order for the  
140 budget to take effect; or

141 (E) has authority to review or approve a contract the police department makes with a  
142 police union or other organization.

143 (b) Nothing in this Subsection (4):

144 (i) limits the authority the Utah Code provides over the chief of police;

145 (ii) prohibits the municipal council or chief executive officer from taking a lawful  
146 action described in Subsection (4)(a)(ii) that is allowed by law; or

147 (iii) limits the authority of a civil service commission established in accordance with  
148 Title 10, Chapter 3, Part 10, Civil Service Commission.

149 (5) Subject to Subsection (4), a municipality may establish a board, committee, or other  
150 entity that relates to the provision of law enforcement services and that has authority  
151 independent of the chief of police if the municipality:

- 152 (a) directly appoints the board, committee, or other entity's members; and
- 153 (b) provides direct oversight of the board, committee, or other entity.

154 Section 2. Section 17-16-21 is amended to read:

155 **17-16-21. Fees of county officers.**

156 (1) As used in this section, "county officer" means a county officer enumerated in  
157 Section 17-53-101 except a county recorder, a county constable, or a county sheriff.

158 (2) (a) A county officer shall collect, in advance, for exclusive county use and benefit:

- 159 (i) a fee established by the county legislative body under Section 17-53-211; and
- 160 (ii) any other fee authorized or required by law.

161 (b) As long as the Children's Legal Defense Account is authorized by Section  
162 51-9-408, the county clerk shall:

163 (i) assess \$10 in addition to whatever fee for a marriage license is established under  
164 authority of this section; and

165 (ii) transmit \$10 from each marriage license fee to the Division of Finance for deposit  
166 in the Children's Legal Defense Account.

167 (c) (i) As long as the Division of Child and Family Services, created in Section  
168 ~~[62A-4a-103]~~ 80-2-201, has the responsibility under Section ~~[62A-4a-105]~~ 80-2-301 to provide  
169 services, including temporary shelter, for victims of domestic violence, the county clerk shall:

170 (A) collect \$10 in addition to whatever fee for a marriage license is established under  
171 authority of this section and in addition to the amount described in Subsection (2)(b), if an  
172 applicant chooses, as provided in Subsection (2)(c)(ii), to pay the additional \$10; and

173 (B) to the extent actually paid, transmit \$10 from each marriage license fee to the  
174 Division of Finance for distribution to the Division of Child and Family Services for the  
175 operation of shelters for victims of domestic violence.

176 (ii) (A) The county clerk shall provide a method for an applicant for a marriage license  
177 to choose to pay the additional \$10 referred to in Subsection (2)(c)(i).

178 (B) An applicant for a marriage license may choose not to pay the additional \$10  
179 referred to in Subsection (2)(c)(i) without affecting the applicant's ability to be issued a  
180 marriage license.

181 (d) If a county operates an online marriage application system, the county clerk of that  
182 county:

183 (i) may assess \$20 in addition to the other fees for a marriage license established under  
184 this section;

185 (ii) except as provided in Subsection (2)(d)(iii), shall transmit \$20 from the marriage  
186 license fee to the state treasurer for deposit annually as follows:

187 (A) the first \$400,000 shall accrue to the Utah Marriage Commission, created in Title  
188 63M, Chapter 15, Utah Marriage Commission, as dedicated credits for the operation of the  
189 Utah Marriage Commission; and

190 (B) proceeds in excess of \$400,000 shall be deposited into the General Fund; and

191 (iii) may not transmit \$20 from the marriage license fee to the state treasurer under this  
192 Subsection (2)(d) if both individuals seeking the marriage license certify that they have  
193 completed premarital counseling or education in accordance with Section 30-1-34.

194 (3) This section does not apply to a fee currently being assessed by the state but  
195 collected by a county officer.

196 Section 3. Section 17-22-2 is amended to read:

197 **17-22-2. Sheriff -- General duties.**

198 (1) The sheriff shall:

199 (a) preserve the peace;

200 (b) make all lawful arrests;

201 (c) attend in person or by deputy the Supreme Court and the Court of Appeals when  
202 required or when the court is held within his county, all courts of record, and court  
203 commissioner and referee sessions held within his county, obey their lawful orders and  
204 directions, and comply with the court security rule, Rule 3-414, of the Utah Code of Judicial  
205 Administration;

206 (d) upon request of the juvenile court, aid the court in maintaining order during  
207 hearings and transport a minor to and from youth corrections facilities, other institutions, or  
208 other designated places;

209 (e) attend county justice courts if the judge finds that the matter before the court  
210 requires the sheriff's attendance for security, transportation, and escort of jail prisoners in his  
211 custody, or for the custody of jurors;

212 (f) command the aid of as many inhabitants of his county as he considers necessary in  
213 the execution of these duties;

214 (g) take charge of and keep the county jail and the jail prisoners;  
215 (h) receive and safely keep all persons committed to his custody, file and preserve the  
216 commitments of those persons, and record the name, age, place of birth, and description of  
217 each person committed;

218 (i) release on the record all attachments of real property when the attachment he  
219 receives has been released or discharged;

220 (j) endorse on all process and notices the year, month, day, hour, and minute of  
221 reception, and, upon payment of fees, issue a certificate to the person delivering process or  
222 notice showing the names of the parties, title of paper, and the time of receipt;

223 (k) serve all process and notices as prescribed by law;

224 (l) if he makes service of process or notice, certify on the process or notices the  
225 manner, time, and place of service, or, if he fails to make service, certify the reason upon the  
226 process or notice, and return them without delay;

227 (m) extinguish fires occurring in the undergrowth, trees, or wooded areas on the public  
228 land within his county;

229 (n) perform as required by any contracts between the county and private contractors for  
230 management, maintenance, operation, and construction of county jails entered into under the  
231 authority of Section [17-53-311](#);

232 (o) for the sheriff of a county of the second through sixth class that enters into an  
233 interlocal agreement for law enforcement service under Title 11, Chapter 13, Interlocal  
234 Cooperation Act, provide law enforcement service as provided in the interlocal agreement;

235 (p) manage search and rescue services in his county;

236 (q) obtain saliva DNA specimens as required under Section [53-10-404](#);

237 (r) on or before January 1, 2003, adopt a written policy that prohibits the stopping,  
238 detention, or search of any person when the action is solely motivated by considerations of  
239 race, color, ethnicity, age, or gender;

240 (s) as applicable, select a representative of law enforcement to serve as a member of a  
241 child protection team, as defined in Section [~~62A-4a-101~~] [80-1-102](#); and

242 (t) perform any other duties that are required by law.

243 (2) Violation of Subsection (1)(j) is a class C misdemeanor. Violation of any other  
244 subsection under Subsection (1) is a class A misdemeanor.



245 (3) (a) As used in this Subsection (3):

246 (i) "Police interlocal entity" has the same meaning as defined in Sections 17-30-3 and  
247 17-30a-102.

248 (ii) "Police local district" has the same meaning as defined in Section 17-30-3.

249 (b) Except as provided in Subsections (3)(c) and 11-13-202(4), a sheriff in a county  
250 which includes within its boundary a police local district or police interlocal entity, or both:

251 (i) serves as the chief executive officer of each police local district and police interlocal  
252 entity within the county with respect to the provision of law enforcement service within the  
253 boundary of the police local district or police interlocal entity, respectively; and

254 (ii) is subject to the direction of the police local district board of trustees or police  
255 interlocal entity governing body, as the case may be, as and to the extent provided by  
256 agreement between the police local district or police interlocal entity, respectively, and the  
257 sheriff.

258 (c) Notwithstanding Subsection (3)(b), and except as provided in Subsection  
259 11-13-202(4), if a police interlocal entity or police local district enters an interlocal agreement  
260 with a public agency, as defined in Section 11-13-103, for the provision of law enforcement  
261 service, the sheriff:

262 (i) does not serve as the chief executive officer of any interlocal entity created under  
263 that interlocal agreement, unless the agreement provides for the sheriff to serve as the chief  
264 executive officer; and

265 (ii) shall provide law enforcement service under that interlocal agreement as provided  
266 in the agreement.

267 Section 4. Section 26-2-12.5 is amended to read:

268 **26-2-12.5. Certified copies of birth certificates -- Fees credited to Children's**  
269 **Account.**

270 (1) In addition to the fees provided for in Section 26-1-6, the department and local  
271 registrars authorized to issue certified copies shall charge an additional \$3 fee for each certified  
272 copy of a birth certificate, including certified copies of supplementary and amended birth  
273 certificates, under Sections 26-2-8 through 26-2-11. This additional fee may be charged only  
274 for the first copy requested at any one time.

275 (2) The fee shall be transmitted monthly to the state treasurer and credited to the

276 Children's Account established in Section [~~62A-4a-309~~] [80-2-501](#).

277 Section 5. Section ~~26-6-27~~ is amended to read:

278 **26-6-27. Information regarding communicable or reportable diseases**  
279 **confidentiality -- Exceptions.**

280 (1) Information collected pursuant to this chapter in the possession of the department  
281 or local health departments relating to an individual who has or is suspected of having a disease  
282 designated by the department as a communicable or reportable disease under this chapter shall  
283 be held by the department and local health departments as strictly confidential. The department  
284 and local health departments may not release or make public that information upon subpoena,  
285 search warrant, discovery proceedings, or otherwise, except as provided by this section.

286 (2) The information described in Subsection (1) may be released by the department or  
287 local health departments only in accordance with the requirements of this chapter and as  
288 follows:

289 (a) specific medical or epidemiological information may be released with the written  
290 consent of the individual identified in that information or, if that individual is deceased, his  
291 next-of-kin;

292 (b) specific medical or epidemiological information may be released to medical  
293 personnel or peace officers in a medical emergency, as determined by the department in  
294 accordance with guidelines it has established, only to the extent necessary to protect the health  
295 or life of the individual identified in the information, or of the attending medical personnel or  
296 law enforcement or public safety officers;

297 (c) specific medical or epidemiological information may be released to authorized  
298 personnel within the department, local health departments, public health authorities, official  
299 health agencies in other states, the United States Public Health Service, the Centers for Disease  
300 Control and Prevention (CDC), or when necessary to continue patient services or to undertake  
301 public health efforts to interrupt the transmission of disease;

302 (d) if the individual identified in the information is under the age of 18, the information  
303 may be released to the Division of Child and Family Services within the Department of Human  
304 Services in accordance with Section [~~62A-4a-403~~] [80-2-602](#). If that information is required in  
305 a court proceeding involving child abuse or sexual abuse under Title 76, Chapter 5, Offenses  
306 Against the Person, the information shall be disclosed in camera and sealed by the court upon

307 conclusion of the proceedings;

308 (e) specific medical or epidemiological information may be released to authorized  
309 personnel in the department or in local health departments, and to the courts, to carry out the  
310 provisions of this title, and rules adopted by the department in accordance with this title;

311 (f) specific medical or epidemiological information may be released to blood banks,  
312 organ and tissue banks, and similar institutions for the purpose of identifying individuals with  
313 communicable diseases. The department may, by rule, designate the diseases about which  
314 information may be disclosed under this subsection, and may choose to release the name of an  
315 infected individual to those organizations without disclosing the specific disease;

316 (g) specific medical or epidemiological information may be released in such a way that  
317 no individual is identifiable;

318 (h) specific medical or epidemiological information may be released to a "health care  
319 provider" as defined in Section 78B-3-403, health care personnel, and public health personnel  
320 who have a legitimate need to have access to the information in order to assist the patient, or to  
321 protect the health of others closely associated with the patient;

322 (i) specific medical or epidemiological information regarding a health care provider, as  
323 defined in Section 78B-3-403, may be released to the department, the appropriate local health  
324 department, and the Division of Occupational and Professional Licensing within the  
325 Department of Commerce, if the identified health care provider is endangering the safety or life  
326 of any individual by his continued practice of health care;

327 (j) specific medical or epidemiological information may be released in accordance with  
328 Section 26-6-31 if an individual is not identifiable; and

329 (k) specific medical or epidemiological information may be released to a state agency  
330 as defined in Section 63A-17-901, to perform the analysis described in Subsection 26-6-32(4)  
331 if the state agency agrees to act in accordance with the requirements in this chapter.

332 (3) The provisions of Subsection (2)(h) do not create a duty to warn third parties, but is  
333 intended only to aid health care providers in their treatment and containment of infectious  
334 disease.

335 Section 6. Section 26-8a-310 is amended to read:

336 **26-8a-310. Background clearance for emergency medical service personnel.**

337 (1) Subject to Section 26-8a-310.5, the department shall determine whether to grant

338 background clearance for an individual seeking licensure or certification under Section  
339 [26-8a-302](#) from whom the department receives:

340 (a) the individual's social security number, fingerprints, and other personal  
341 identification information specified by the department under Subsection (4); and

342 (b) any fees established by the department under Subsection (10).

343 (2) The department shall determine whether to deny or revoke background clearance  
344 for individuals for whom the department has previously granted background clearance.

345 (3) The department shall determine whether to grant, deny, or revoke background  
346 clearance for an individual based on an initial and ongoing evaluation of information the  
347 department obtains under Subsections (5) and (11), which, at a minimum, shall include an  
348 initial criminal background check of state, regional, and national databases using the  
349 individual's fingerprints.

350 (4) The department shall make rules, in accordance with Title 63G, Chapter 3, Utah  
351 Administrative Rulemaking Act, that specify:

352 (a) the criteria the department will use under Subsection (3) to determine whether to  
353 grant, deny, or revoke background clearance; and

354 (b) the other personal identification information an individual seeking licensure or  
355 certification under Section [26-8a-302](#) must submit under Subsection (1).

356 (5) To determine whether to grant, deny, or revoke background clearance, the  
357 department may access and evaluate any of the following:

358 (a) Department of Public Safety arrest, conviction, and disposition records described in  
359 Title 53, Chapter 10, Criminal Investigations and Technical Services Act, including  
360 information in state, regional, and national records files;

361 (b) adjudications by a juvenile court of committing an act that if committed by an adult  
362 would be a felony or misdemeanor, if:

363 (i) the applicant is under 28 years old; or

364 (ii) the applicant:

365 (A) is over 28 years old; and

366 (B) has been convicted of, has pleaded no contest to, or is currently subject to a plea in  
367 abeyance or diversion agreement for a felony or misdemeanor;

368 (c) juvenile court arrest, adjudication, and disposition records, other than those under

- 369 Subsection (5)(b), as allowed under Section [78A-6-209](#);
- 370 (d) child abuse or neglect findings described in Section [80-3-404](#);
- 371 (e) the Department of Human Services' Division of Child and Family Services
- 372 Licensing Information System described in Section [~~62A-4a-1006~~] [80-2-1002](#);
- 373 (f) the Department of Human Services' Division of Aging and Adult Services database

1987 (5) (a) After conducting the background check described in Subsections (3) and (4), the  
1988 office shall deny an application to an applicant who, within three years before the day on which  
1989 the applicant submits information to the office under Subsection (2) for a background check,  
1990 has been convicted of any of the following, regardless of whether the offense is a felony, a  
1991 misdemeanor, or an infraction:

1992 (i) an offense identified as domestic violence, lewdness, voyeurism, battery, cruelty to

2004 (ix) a felony or misdemeanor offense committed outside of the state that, if committed  
2005 in the state, would constitute a violation of an offense described in Subsections (5)(a)(i)  
2006 through (viii).

2007 (b) If the office denies an application to an applicant based on a conviction described in  
2008 Subsection (5)(a), the applicant is not entitled to a comprehensive review described in  
2009 Subsection (6).

2010 (c) If the applicant will be working in a program serving only adults whose only  
2011 impairment is a mental health diagnosis, including that of a serious mental health disorder,

2012 with or without co-occurring substance use disorder, the denial provisions of Subsection (5)(a)

2032 (vi) has a listing in the Department of Human Services, Division of Aging and Adult  
2033 Services' vulnerable adult abuse, neglect, or exploitation database described in Section  
2034 [62A-3-311.1](#);

2035 (vii) has a record in the juvenile court of a substantiated finding of severe child abuse  
2036 or neglect described in Section [80-3-404](#);

2037 (viii) has a record of an adjudication in juvenile court for an act that, if committed by  
2038 an adult, would be a felony or misdemeanor, if the applicant is:

2039 (A) under 28 years old; or

2040 (B) 28 years old or older and has been convicted of, has pleaded no contest to, or is  
2041 currently subject to a plea in abeyance or diversion agreement for a felony or a misdemeanor  
2042 offense described in Subsection (5)(a);

- 2043 (ix) has a pending charge for an offense described in Subsection (5)(a); or
- 2044 (x) is an applicant described in Subsection (5)(c).
- 2045 (b) The comprehensive review described in Subsection (6)(a) shall include an
- 2046 examination of:
  - 2047 (i) the date of the offense or incident;
  - 2048 (ii) the nature and seriousness of the offense or incident;
  - 2049 (iii) the circumstances under which the offense or incident occurred;
  - 2050 (iv) the age of the perpetrator when the offense or incident occurred;
  - 2051 (v) whether the offense or incident was an isolated or repeated incident;
