**LONG TITLE**

**General Description:**

This bill creates the Office of the Education Ombudsman.

- ▶ requires the office to report to the Education Interim Committee;
- ▶ defines terms;
- ▶ establishes the duties of the office;
- ▶ enacts provisions governing liability and protected communications of the office;
- ▶ enacts provisions governing office confidentiality and privilege;
- ▶ amends provisions protecting certain records created or submitted to the office; and
- ▶ makes conforming changes.

107 **Part 8. Office of the Education Ombudsman**

108 **53E-10-801. Definitions.**

109 As used in this part:

110 (1) "Office" means the Office of the Education Ombudsman created in Section  
111 53E-10-802.

112 (2) "Ombudsman" means the individual appointed under Section 53E-10-802.

113 Section 3. Section 53E-10-802 is enacted to read:

114 **53E-10-802. Office of the Education Ombudsman.**

115 (1) There is created in the governor's office the Office of the Education Ombudsman.

116 (2) The governor's office shall employ an individual with a background and expertise  
117 in state and federal elementary and secondary education law and policy to:

118 (a) serve as the ombudsman; and

119 (b) direct the office.

120 (3) An individual employed as the ombudsman:

121 (a) is an exempt employee; and

122 (b) may be terminated without cause.

123 Section 4. Section **53E-10-803** is enacted to read:

124 **53E-10-803. Duties.**

125 (1) Subject to Subsection (2), the office shall:

126 (a) develop and maintain expertise in state and federal kindergarten, elementary, and

127 secondary education law;

128 (b) develop parental involvement materials, including instructional guides to inform

129 parents of:

130 (i) the core standards implemented in accordance with Section [53E-4-202](#);

131 (ii) a statewide assessment, as defined in Section [53E-4-301](#);

132 (iii) education governance and administration, including the respective roles of the

133 Legislature, state board, an LEA governing board, LEA administrators, school administrators,

134 and parents;

135 (iv) the requirements of Title 53, Chapter 4, Open and Public Meetings Act;

136 (v) a program or curriculum that, under a state law or a policy or rule, a parent has a

137 right to consent to before a student may participate in the program or receive the curriculum;

138 (vi) school discipline regulations and procedures as described in Title 53G, Chapter 8,

139 Discipline and Safety; and

140 (vii) resources to support parents in assisting with their student's education;

141 (c) provide information to students, parents, and members of the public regarding the

142 state's kindergarten, elementary, and secondary school system;

143 (d) facilitate the resolution of complaints made by parents, students, and, except as

144 provided in Subsection (2)(a)(ii), teachers with regard to the state's kindergarten, elementary,

145 and secondary education system; and

146 (e) refer complaints, if necessary, or individuals who need further assistance to

147 appropriate state and federal agencies or resources.

148 (2) The office may not:

149 (a) facilitate complaints concerning the following:

150 (i) an elected member of the state board or an LEA governing board;  
151 (ii) an allegation or complaint in which the investigation or resolution of is governed  
152 by Chapter 6, Education Professional Licensure; or

153 (iii) a complaint regarding an individualized education program or Section 504  
154 accommodation plan; or

155 (b) respond to inquiries or complaints about:

156 (i) a private school;

157 (ii) a preschool;

158 (iii) a childcare center;

159 (iv) a public or private institution of higher education; or

160 (v) any other private organization, business, or entity.

161 (3) The office may not charge a fee.

162 Section 5. Section **53E-10-804** is enacted to read:

163 **53E-10-804. Liability for good faith performance -- Communications protected.**

164 (1) Neither the ombudsman nor an employee of the office is liable for good faith  
165 performance of responsibilities under this part.

166 (2) (a) Neither the office nor an individual attorney employed by the office, if any, may  
167 represent a person in a legal action that arises from or relates to a matter addressed in this part.

168 (b) An action by an attorney employed by the office, if any, does not create an  
169 attorney-client relationship between the office or the office's attorney and a person.

170 (3) (a) No discriminatory, disciplinary, or retaliatory action may be taken against any  
171 student, employee of an LEA, or an employee of the state board, for any communication made,  
172 or information given or disclosed, to aid an employee of the office in carrying out the  
173 employee's duties and responsibilities, unless the communication is made, or information is  
174 given or disclosed, without good faith or maliciously.

175 (b) The provisions of Subsection (3)(a) do not prohibit an LEA or the state board from  
176 supervising, disciplining, or terminating an employee for reasons other than those described in  
177 Subsection (3)(a).

178 (4) (a) A communication by the ombudsman or an employee of the office, if reasonably  
179 related to duties and responsibilities as described in this part, and done in good faith, are  
180 privileged.

181 (b) The privilege created in Subsection (4)(a) is a defense to any action in libel or  
182 slander.

183 Section 6. Section **53E-10-805** is enacted to read:

184 **53E-10-805. Confidentiality.**

185 (1) The office shall treat all matters, including the identities of parents, students,  
186 complainants, and individuals from whom information is acquired, as confidential, except as  
187 necessary to enable the office to perform the duties as described in this part.

188 (2) Upon receipt of information that by law is confidential or privileged, the office:

189 (a) shall maintain the confidentiality; and

190 (b) may not disclose or disseminate the information except as provided by applicable  
191 state or federal law.

192 Section 7. Section **53E-10-806** is enacted to read:

193 **53E-10-806. Report.**

194 (1) No later than November 1, the ombudsman shall, in accordance with Section  
195 68-3-14, report annually to the Education Interim Committee.

196 (2) The report shall include:

197 (a) by district and aggregated across the state:

198 (i) what services of the office have been requested and by whom without identifying  
199 individual requestors; and

200 (ii) an accounting of the most frequent type of conflicts the office is asked to help  
201 resolve;

202 (b) materials and trainings the office has created or conducted in the last year;

203 (c) recommendations to eliminate barriers and obstacles to meaningful parent and  
204 community involvement in public education; and

205 (d) any other information requested by the Education Interim Committee.

206 Section 8. Section **63G-2-305** is amended to read:

207 **63G-2-305. Protected records.**

208 The following records are protected if properly classified by a governmental entity:

209 (1) trade secrets as defined in Section 13-24-2 if the person submitting the trade secret  
210 has provided the governmental entity with the information specified in Section 63G-2-309;

211 (2) commercial information or nonindividual financial information obtained from a

212 person if:

213 (a) disclosure of the information could reasonably be expected to result in unfair  
214 competitive injury to the person submitting the information or would impair the ability of the  
215 governmental entity to obtain necessary information in the future;

216 (b) the person submitting the information has a greater interest in prohibiting access  
217 than the public in obtaining access; and

218 (c) the person submitting the information has provided the governmental entity with  
219 the information specified in Section [63G-2-309](#);

220 (3) commercial or financial information acquired or prepared by a governmental entity  
221 to the extent that disclosure would lead to financial speculations in currencies, securities, or  
222 commodities that will interfere with a planned transaction by the governmental entity or cause  
223 substantial financial injury to the governmental entity or state economy;

224 (4) records, the disclosure of which could cause commercial injury to, or confer a  
225 competitive advantage upon a potential or actual competitor of, a commercial project entity as  
226 defined in Subsection [11-13-103\(4\)](#);

227 (5) test questions and answers to be used in future license, certification, registration,  
228 employment, or academic examinations;

229 (6) records, the disclosure of which would impair governmental procurement  
230 proceedings or give an unfair advantage to any person proposing to enter into a contract or  
231 agreement with a governmental entity, except, subject to Subsections (1) and (2), that this  
232 Subsection (6) does not restrict the right of a person to have access to, after the contract or  
233 grant has been awarded and signed by all parties:

234 (a) a bid, proposal, application, or other information submitted to or by a governmental  
235 entity in response to:

236 (i) an invitation for bids;

237 (ii) a request for proposals;

238 (iii) a request for quotes;

239 (iv) a grant; or

240 (v) other similar document; or

241 (b) an unsolicited proposal, as defined in Section [63G-6a-712](#);

242 (7) information submitted to or by a governmental entity in response to a request for



243 information, except, subject to Subsections (1) and (2), that this Subsection (7) does not restrict  
244 the right of a person to have access to the information, after:

245 (a) a contract directly relating to the subject of the request for information has been  
246 awarded and signed by all parties; or

247 (b) (i) a final determination is made not to enter into a contract that relates to the  
248 subject of the request for information; and

249 (ii) at least two years have passed after the day on which the request for information is  
250 issued;

251 (8) records that would identify real property or the appraisal or estimated value of real  
252 or personal property, including intellectual property, under consideration for public acquisition  
253 before any rights to the property are acquired unless:

254 (a) public interest in obtaining access to the information is greater than or equal to the  
255 governmental entity's need to acquire the property on the best terms possible;

256 (b) the information has already been disclosed to persons not employed by or under a  
257 duty of confidentiality to the entity;

258 (c) in the case of records that would identify property, potential sellers of the described  
259 property have already learned of the governmental entity's plans to acquire the property;

260 (d) in the case of records that would identify the appraisal or estimated value of  
261 property, the potential sellers have already learned of the governmental entity's estimated value  
262 of the property; or

263 (e) the property under consideration for public acquisition is a single family residence  
264 and the governmental entity seeking to acquire the property has initiated negotiations to acquire  
265 the property as required under Section [78B-6-505](#);

266 (9) records prepared in contemplation of sale, exchange, lease, rental, or other  
267 compensated transaction of real or personal property including intellectual property, which, if  
268 disclosed prior to completion of the transaction, would reveal the appraisal or estimated value  
269 of the subject property, unless:

270 (a) the public interest in access is greater than or equal to the interests in restricting  
271 access, including the governmental entity's interest in maximizing the financial benefit of the  
272 transaction; or

273 (b) when prepared by or on behalf of a governmental entity, appraisals or estimates of

274 the value of the subject property have already been disclosed to persons not employed by or  
275 under a duty of confidentiality to the entity;

276 (10) records created or maintained for civil, criminal, or administrative enforcement  
277 purposes or audit purposes, or for discipline, licensing, certification, or registration purposes, if  
278 release of the records:

279 (a) reasonably could be expected to interfere with investigations undertaken for  
280 enforcement, discipline, licensing, certification, or registration purposes;

281 (b) reasonably could be expected to interfere with audits, disciplinary, or enforcement  
282 proceedings;

283 (c) would create a danger of depriving a person of a right to a fair trial or impartial  
284 hearing;

285 (d) reasonably could be expected to disclose the identity of a source who is not  
286 generally known outside of government and, in the case of a record compiled in the course of  
287 an investigation, disclose information furnished by a source not generally known outside of  
288 government if disclosure would compromise the source; or

289 (e) reasonably could be expected to disclose investigative or audit techniques,  
290 procedures, policies, or orders not generally known outside of government if disclosure would  
291 interfere with enforcement or audit efforts;

292 (11) records the disclosure of which would jeopardize the life or safety of an  
293 individual;

294 (12) records the disclosure of which would jeopardize the security of governmental  
295 property, governmental programs, or governmental recordkeeping systems from damage, theft,  
296 or other appropriation or use contrary to law or public policy;

297 (13) records that, if disclosed, would jeopardize the security or safety of a correctional  
298 facility, or records relating to incarceration, treatment, probation, or parole, that would interfere  
299 with the control and supervision of an offender's incarceration, treatment, probation, or parole;

300 (14) records that, if disclosed, would reveal recommendations made to the Board of  
301 Pardons and Parole by an employee of or contractor for the Department of Corrections, the  
302 Board of Pardons and Parole, or the Department of Human Services that are based on the  
303 employee's or contractor's supervision, diagnosis, or treatment of any person within the board's  
304 jurisdiction;

305 (15) records and audit workpapers that identify audit, collection, and operational  
306 procedures and methods used by the State Tax Commission, if disclosure would interfere with  
307 audits or collections;

308 (16) records of a governmental audit agency relating to an ongoing or planned audit  
309 until the final audit is released;

310 (17) records that are subject to the attorney client privilege;

311 (18) records prepared for or by an attorney, consultant, surety, indemnitor, insurer,  
312 employee, or agent of a governmental entity for, or in anticipation of, litigation or a judicial,  
313 quasi-judicial, or administrative proceeding;

314 (19) (a) (i) personal files of a state legislator, including personal correspondence to or  
315 from a member of the Legislature; and

316 (ii) notwithstanding Subsection (19)(a)(i), correspondence that gives notice of  
317 legislative action or policy may not be classified as protected under this section; and

318 (b) (i) an internal communication that is part of the deliberative process in connection  
319 with the preparation of legislation between:

320 (A) members of a legislative body;

321 (B) a member of a legislative body and a member of the legislative body's staff; or

322 (C) members of a legislative body's staff; and

323 (ii) notwithstanding Subsection (19)(b)(i), a communication that gives notice of  
324 legislative action or policy may not be classified as protected under this section;

325 (20) (a) records in the custody or control of the Office of Legislative Research and  
326 General Counsel, that, if disclosed, would reveal a particular legislator's contemplated  
327 legislation or contemplated course of action before the legislator has elected to support the  
328 legislation or course of action, or made the legislation or course of action public; and

329 (b) notwithstanding Subsection (20)(a), the form to request legislation submitted to the  
330 Office of Legislative Research and General Counsel is a public document unless a legislator  
331 asks that the records requesting the legislation be maintained as protected records until such  
332 time as the legislator elects to make the legislation or course of action public;

333 (21) research requests from legislators to the Office of Legislative Research and  
334 General Counsel or the Office of the Legislative Fiscal Analyst and research findings prepared  
335 in response to these requests;

- 336 (22) drafts, unless otherwise classified as public;
- 337 (23) records concerning a governmental entity's strategy about:
- 338 (a) collective bargaining; or
- 339 (b) imminent or pending litigation;
- 340 (24) records of investigations of loss occurrences and analyses of loss occurrences that
- 341 may be covered by the Risk Management Fund, the Employers' Reinsurance Fund, the
- 342 Uninsured Employers' Fund, or similar divisions in other governmental entities;
- 343 (25) records, other than personnel evaluations, that contain a personal recommendation
- 344 concerning an individual if disclosure would constitute a clearly unwarranted invasion of
- 345 personal privacy, or disclosure is not in the public interest;
- 346 (26) records that reveal the location of historic, prehistoric, paleontological, or
- 347 biological resources that if known would jeopardize the security of those resources or of
- 348 valuable historic, scientific, educational, or cultural information;
- 349 (27) records of independent state agencies if the disclosure of the records would
- 350 conflict with the fiduciary obligations of the agency;
- 351 (28) records of an institution within the state system of higher education defined in
- 352 Section [53B-1-102](#) regarding tenure evaluations, appointments, applications for admissions,
- 353 retention decisions, and promotions, which could be properly discussed in a meeting closed in
- 354 accordance with Title 52, Chapter 4, Open and Public Meetings Act, provided that records of
- 355 the final decisions about tenure, appointments, retention, promotions, or those students
- 356 admitted, may not be classified as protected under this section;
- 357 (29) records of the governor's office, including budget recommendations, legislative
- 358 proposals, and policy statements, that if disclosed would reveal the governor's contemplated
- 359 policies or contemplated courses of action before the governor has implemented or rejected
- 360 those policies or courses of action or made them public;
- 361 (30) records of the Office of the Legislative Fiscal Analyst relating to budget analysis,
- 362 revenue estimates, and fiscal notes of proposed legislation before issuance of the final
- 363 recommendations in these areas;
- 364 (31) records provided by the United States or by a government entity outside the state
- 365 that are given to the governmental entity with a requirement that they be managed as protected
- 366 records if the providing entity certifies that the record would not be subject to public disclosure

367 if retained by it;

368 (32) transcripts, minutes, recordings, or reports of the closed portion of a meeting of a  
369 public body except as provided in Section 52-4-206;

370 (33) records that would reveal the contents of settlement negotiations but not including  
371 final settlements or empirical data to the extent that they are not otherwise exempt from  
372 disclosure;

373 (34) memoranda prepared by staff and used in the decision-making process by an  
374 administrative law judge, a member of the Board of Pardons and Parole, or a member of any  
375 other body charged by law with performing a quasi-judicial function;

376 (35) records that would reveal negotiations regarding assistance or incentives offered  
377 by or requested from a governmental entity for the purpose of encouraging a person to expand  
378 or locate a business in Utah, but only if disclosure would result in actual economic harm to the  
379 person or place the governmental entity at a competitive disadvantage, but this section may not  
380 be used to restrict access to a record evidencing a final contract;

381 (36) materials to which access must be limited for purposes of securing or maintaining  
382 the governmental entity's proprietary protection of intellectual property rights including patents,  
383 copyrights, and trade secrets;

384 (37) the name of a donor or a prospective donor to a governmental entity, including an  
385 institution within the state system of higher education defined in Section 53B-1-102, and other  
386 information concerning the donation that could reasonably be expected to reveal the identity of  
387 the donor, provided that:

388 (a) the donor requests anonymity in writing;

389 (b) any terms, conditions, restrictions, or privileges relating to the donation may not be  
390 classified protected by the governmental entity under this Subsection (37); and

391 (c) except for an institution within the state system of higher education defined in  
392 Section 53B-1-102, the governmental unit to which the donation is made is primarily engaged  
393 in educational, charitable, or artistic endeavors, and has no regulatory or legislative authority  
394 over the donor, a member of the donor's immediate family, or any entity owned or controlled  
395 by the donor or the donor's immediate family;

396 (38) accident reports, except as provided in Sections 41-6a-404, 41-12a-202, and  
397 73-18-13;

398 (39) a notification of workers' compensation insurance coverage described in Section  
399 34A-2-205;

400 (40) (a) the following records of an institution within the state system of higher  
401 education defined in Section 53B-1-102, which have been developed, discovered, disclosed to,  
402 or received by or on behalf of faculty, staff, employees, or students of the institution:

403 (i) unpublished lecture notes;

404 (ii) unpublished notes, data, and information:

405 (A) relating to research; and

406 (B) of:

407 (I) the institution within the state system of higher education defined in Section  
408 53B-1-102; or

409 (II) a sponsor of sponsored research;

410 (iii) unpublished manuscripts;

411 (iv) creative works in process;

412 (v) scholarly correspondence; and

413 (vi) confidential information contained in research proposals;

414 (b) Subsection (40)(a) may not be construed to prohibit disclosure of public  
415 information required pursuant to Subsection 53B-16-302(2)(a) or (b); and

416 (c) Subsection (40)(a) may not be construed to affect the ownership of a record;

417 (41) (a) records in the custody or control of the Office of the Legislative Auditor  
418 General that would reveal the name of a particular legislator who requests a legislative audit  
419 prior to the date that audit is completed and made public; and

420 (b) notwithstanding Subsection (41)(a), a request for a legislative audit submitted to the  
421 Office of the Legislative Auditor General is a public document unless the legislator asks that  
422 the records in the custody or control of the Office of the Legislative Auditor General that would  
423 reveal the name of a particular legislator who requests a legislative audit be maintained as  
424 protected records until the audit is completed and made public;

425 (42) records that provide detail as to the location of an explosive, including a map or  
426 other document that indicates the location of:

427 (a) a production facility; or

428 (b) a magazine;

429 (43) information:

430 (a) contained in the statewide database of the Division of Aging and Adult Services  
431 created by Section [62A-3-311.1](#); or

432 (b) received or maintained in relation to the Identity Theft Reporting Information
