

Representative Jordan D. Teuscher proposes the following substitute bill:

ATHLETIC COACHING STANDARDS AMENDMENTS

2022 GENERAL SESSION

LONG TITLE

General Description:

This bill addresses standards for, and the evaluation of, high school athletic coaches.

Highlighted Provisions:

This bill:

- ▶ defines terms;
- ▶ requires a local education agency (LEA) to develop coaching standards for high school athletic coaches;
- ▶ requires a principal to conduct an annual standardized evaluation of a head coach based on the standards developed by the LEA;
- ▶ requires a principal to provide a coach with a copy of a completed evaluation; and
- ▶ for an athletic coach who is also an educator, prohibits an LEA from taking action in relation to the coach's status as an educator based on an evaluation of the coach's performance as a coach.

29 *Be it enacted by the Legislature of the state of Utah:*

30 Section 1. Section **53G-7-221** is enacted to read:

31 **53G-7-221. Athletic coach evaluations.**

32 (1) As used in this section:

33 (a) "Association" means the same as that term is defined in Section [53G-7-1101](#).

34 (b) "Athletic coach" means an individual who, on behalf of an LEA, coaches students
35 participating in a sport.

36 (c) "Classification" means the same as that term is defined in Section [53G-7-1101](#).

37 (d) "Completed coach evaluation" means a completed evaluation described in
38 Subsection (3), including any response provided by a coach as described in Subsection (4).

39 (e) "Contest" means an interscholastic meet, game, tournament, or other competitive
40 activity.

41 (f) "Interscholastic activity" means the same as that term is defined in Section
42 [53G-7-1101](#).

43 (g) "LEA" means a school district or charter school that serves students in grade 9, 10,
44 11, or 12.

45 (h) "Sport" means an athletic interscholastic activity sanctioned by an association.

46 (i) (i) "Sport season" means the competition season for a sport.

47 (ii) A sport season ends on the day of the last sanctioned state contest for the sport,
48 regardless of whether the last sanctioned state contest is for schools in a different classification.

49 (2) (a) In consultation with an association and groups and organizations that represent
50 athletic coaches in the state, an LEA shall establish:

51 (i) professional standards for athletic coaches; and

52 (ii) an evaluation form to be used to evaluate an athletic coach's performance relative to
53 the standards established under Subsection (2)(a)(i).

54 (b) The standards established under Subsection (2)(a) shall include standards related to
55 an athletic coach's:

56 (i) relationship with students, administrators, referees, parents, and other stakeholders;

- 57 (ii) training and certification; and
58 (iii) use and management of athletic resources, including fiscal and facility resources.
59 (c) The evaluation form established under Subsection (2)(a) shall include space for an
60 evaluator to include student and parent input regarding an athletic coach.
61 (3) (a) Within 10 business days after a sport season ends, a public school or charter
62 school principal or the principal's designee shall evaluate the school's head athletic coach for
63 that sport using the relevant evaluation form established by the applicable LEA under
64 Subsection (2).
65 (b) An individual performing an evaluation under this section shall include, as part of
66 the evaluation, student and parent input regarding the athletic coach.
67 (4) Upon completion of an evaluation under Subsection (3), the principal or the
68 principal's designee who conducts the evaluation shall provide the coach with:
69 (a) a copy of the evaluation; and
70 (b) a reasonable opportunity to provide a written response to the evaluation.
71 (5) After complying with Subsection (4), an LEA shall maintain the completed coach
72 evaluation as part of the coach's personnel file.
73 (6) An LEA shall classify a completed coach evaluation as a private performance
74 evaluation under Subsection [63G-2-302\(2\)\(a\)](#).
75 (7) For an athletic coach who is also an educator, as that term is defined in Section
76 [53G-11-501](#), an LEA may not take action in relation to the athletic coach's position as an
77 educator based on an evaluation performed under this section.
