LONG TITLE

General Description:

This bill modifies provisions related to license plates and vehicle emissions testing.

Highlighted Provisions:

This bill:

- ▶ defines terms;
- ▶ amends provisions regarding standard license plates;
- ▶ creates a moratorium on the personalized license plate program;
- ▶ creates the sponsored special group license plate program;
- ▶ establishes eligibility criteria for different categories of sponsored special group

license plates;

- ▶ allows a county to exempt a motor vehicle from an emissions inspection under

certain circumstances;

- ▶ repeals certain restricted accounts; and
- ▶ makes technical and conforming changes.

2742 (6) (a) An organization described in Subsection (5) may apply to the division to receive

2744 (b) An organization that receives a distribution from the division in accordance with

2745 Subsection (5) shall expend the distribution only to:

2746 (i) produce and distribute educational and promotional materials on Zion National

2747 Park;
