#### General Description:

This bill amends provisions governing the Office of Child Care.

This bill:

~~{ → } repeals certain provisions requiring the Office of Child Care (office) to determine eligibility for a child care subsidy or grant;~~

- { ▶ requires the office to contract for the creation of a quality child care estimator tool;
- ▶ enacts criteria and requirements for developing the tool;
- ▶ requires the office to prepare a report on the tool development and projected child care costs; and
- ▶ makes conforming changes.

### **35A-3-211. Child care estimator tool.**

(1) As used in this section, "tool" means the cost of quality child care estimator tool created in accordance with this section.

(2) ~~{The office shall, in}~~In accordance with Title 63G, Chapter 6a, Utah Procurement Code, the office shall enter into a contract with a ~~{third-party provider}~~systems developer to create a cost of quality child care estimator tool.

(3) The tool shall:

(a) enable the state to model the actual costs of child care, according to:

(i) systems developed by the office to inform the public of quality child care providers;

(ii) federal guidelines set forth in 45 C.F.R. Sec. 98.45; and

(iii) other factors determined by the office;

(b) meet federal requirements for alternative methodology for rate setting as described in 45 C.F.R. Sec. 98.45 and established by the U.S. Department of Health and Human Services, Office of Child Care; and

(c) be publicly available no later than December 1, 2022.

(4) The office shall consult stakeholders in development of the tool, including:

(a) experts on cost studies and federal approval;

(b) child care providers from a spectrum of service types;

(c) child care resources and referral agencies; and

(d) early childhood care and education advocates.

(5) (a) No later than December 1, 2022, the office shall prepare and make publicly available a report that describes:

(i) factors considered when developing the tool;

(ii) data points used to model costs, including the target wage scale for child care professionals used to create the tool;

(iii) costs based on tiers in the current system described in Subsection (3)(a)(i); and

(iv) projected costs of quality child care in the state of Utah over the next five years.

(b) No later than May 1, 2023, the office shall submit the report described in Subsection (5)(a) and in accordance with Section 68-3-13 to the Economic Development and Workforce Services Interim Committee.
