LONG TITLE

General Description:

This bill amends provisions relating to the administration and security of the election process.

Highlighted Provisions:

This bill:

- ▶ defines terms;
- ▶ requires the posting of certain statistics relating to ballots and the schedule for processing ballots;
- ▶ modifies the qualifications for, and the access provided to, a poll watcher;
- ▶ requires the logging of certain information relating to replicated ballots;
- ▶ requires the separate storage of adjudicated ballots; and
- ▶ makes technical and conforming changes.

35 Section 1. Section [20A-3a-402](#) is amended to read:

36 **[20A-3a-402. Custody of ballots voted at a polling place -- Disposition -- Counting](#)**
 37 **[ballots -- Release of tally.](#)**

38 [~~(1)~~ This section governs ballots voted at a polling place.]

39 (1) (a) For ballots voted at a polling place:

40 [~~(2)~~(a)] (b) [~~The~~] the election officer shall deliver all return envelopes containing valid
 41 ballots and valid provisional ballots that are in the election officer's custody to the counting
 42 center before noon on the day of the official canvass following the election[-];

43 [~~(b)~~] (c) [~~Valid~~] valid ballots, including valid provisional ballots, may be processed and
 44 counted:

45 (i) by the election officer, or poll workers acting under the supervision of the election
 46 officer, before the date of the canvass; and

79 Section 2. Section **20A-3a-404** is enacted to read:

80 **20A-3a-404. Ballot statistics.**

81 (1) Beginning on the day on which a county clerk begins mailing ballots, and ending on
82 the day before the day of the election, the county clerk shall post on the county clerk's website
83 the following daily totals:

84 (a) the number of ballots in the county clerk's possession; and

85 (b) of the number of ballots in the county clerk's possession:

86 (i) the number of ballots that have not yet begun processing;

87 (ii) the number of ballots in process; and

88 (iii) the number of ballots processed.

89 (2) Except as provided in Subsection (4), an election officer shall post and update the
90 data described in Subsection (3) on the election officer's website at 5 p.m. on the following
91 days:

92 (a) the day after the day of the election;

93 (b) until the day described in Subsection (2)(c), each Monday, Wednesday, and Friday
94 after the day described in Subsection (2)(a); and

95 (c) on the last day of the canvass.

96 (3) The data that an election officer is required to post under Subsection (2) includes:

97 (a) the number of ballots, to date, received by the election officer;

98 (b) the number of ballots in possession of the election officer that have been rejected
99 and are not yet cured;

100 (c) the number of provisional ballots in the possession of the election officer that have
101 not been processed;

102 (d) the number of ballots that need to be adjudicated, but have not yet been
103 adjudicated;

104 (e) the number of ballots awaiting duplication; and

105 (f) the number of ballots that have been duplicated.

106 (4) An election officer is not required to update the data described in Subsection (3) on
107 a Monday if the election officer does not process any ballots the preceding Saturday or Sunday.

108 Section 3. Section **20A-3a-801** is amended to read:

109 **20A-3a-801. Watchers.**

110 (1) As used in this section, "administering election officer" means:

111 (a) the election officer; or

112 (b) if the election officer is the lieutenant governor, the county clerk of the county in
113 which an individual will act as a watcher.

114 (2) (a) Any individual who is registered or preregistered to vote in Utah may become a
115 watcher in an election at any time by registering as a watcher with the administering election
116 officer.

117 (b) An individual who registers under Subsection (2)(a) is not required to be certified
118 by a person under Subsection (3) in order to act as a watcher.

119 (c) An individual who registers as a watcher shall notify the administering election
120 officer of the dates, times, and locations that the individual intends to act as a watcher.

121 (d) An election official may not prohibit a watcher from performing a function
122 described in Subsection (4) because the watcher did not provide the notice described in
123 Subsection (2)(c).

124 (e) An administering election officer shall provide a copy of this section, or
125 instructions on how to access an electronic copy of this section, to a watcher at the time the
126 watcher registers under this Subsection (2).

127 (3) (a) A person that is a candidate whose name will appear on the ballot, a qualified
128 write-in candidate for the election, a registered political party, or a political issues committee
129 may certify an individual as an official watcher for the person:

130 (i) by filing an affidavit with the administering election officer responsible to designate
131 an individual as an official watcher for the certifying person; and

132 (ii) if the individual registers as a watcher under Subsection (2)(a).

133 (b) A watcher who is certified by a person under Subsection (3)(a) may not perform the
134 same function described in Subsection (4) at the same time and in the same location as another
135 watcher who is certified by that person.

136 (c) A watcher who is certified by a person under Subsection (3)(a) may designate
137 another individual to serve in the watcher's stead during the watcher's temporary absence by
138 filing with a poll worker an affidavit that designates the individual as a temporary replacement.

139 (4) A watcher may:

140 (a) observe the setup or takedown of a polling location;

141 (b) observe a voter checking in at a polling location;

142 (c) observe the collection, receipt, and processing of a ballot, including a provisional
143 ballot or a ballot cast by a covered voter as defined in Section [20A-16-102](#);

144 (d) observe the transport or transmission of a ballot that is in an election official's
145 custody;

146 (e) observe the opening and inspection of a manual ballot;

147 (f) observe ballot duplication;

148 (g) observe the conduct of logic and accuracy testing described in Section [20A-5-802](#);

149 (h) observe ballot tabulation;

- 150 (i) observe the process of storing and securing a ballot;
- 151 (j) observe a post-election audit;
- 152 (k) observe a canvassing board meeting described in Title 20A, Chapter 4, Part 3,
- 153 Canvassing Returns;
- 154 (l) observe the certification of the results of an election; or
- 155 (m) observe a recount.
- 156 (5) An administering election officer shall:
- 157 (a) permit uniform, nondiscriminatory access for a watcher to observe each stage of an
- 158 election process;
- 159 (b) establish locations for a watcher to observe an event described in Subsection (4)
- 160 from no further than six feet away; and
- 161 (c) for any ballot adjudication, or upload of votes from a voting machine or scanner,
- 162 that is conducted on a computer screen, project the activity onto a screen that is large enough to
- 163 be viewed by each watcher.
- 164 [~~5~~] (6) (a) A watcher may not:
- 165 (i) [~~electronically~~] record an activity described in Subsection (4) if the recording would
- 166 reveal a vote or otherwise violate a voter's privacy or a voter's right to cast a secret ballot;
- 167 (ii) interfere with an activity described in Subsection (4), except to challenge an
- 168 individual's eligibility to vote under Section 20A-3a-803; or
- 169 (iii) divulge information related to the number of votes counted, tabulated, or cast for a
- 170 candidate or ballot proposition until after the election officer makes the information public.
- 171 (b) A person who violates Subsection [~~5~~] (6)(a)(iii) is guilty of a third degree felony.
- 172 [~~6~~] (7) (a) Notwithstanding Subsection (2)(a) or (4), in order to maintain a safe
- 173 working environment for an election official or to protect the safety or security of a ballot, an
- 174 administering election officer may take reasonable action to:
- 175 (i) limit the number of watchers at a single location;
- 176 (ii) remove a watcher for violating a provision of this section;
- 177 (iii) remove a watcher for interfering with an activity described in Subsection (4);
- 178 (iv) designate areas for a watcher to reasonably observe the activities described in
- 179 Subsection (4); or
- 180 (v) ensure that a voter's ballot secrecy is protected throughout the watching process.

181 (b) If an administering election officer limits the number of watchers at a single
182 location under Subsection (6)(a)(i), the administering election officer shall give preferential
183 access to the location to a watcher designated under Subsection (3).

184 (c) An administering election officer may provide a watcher a badge that identifies the
185 watcher and require the watcher to wear the badge while acting as a watcher.

186 Section 4. Section **20A-3a-807** is enacted to read:

187 **20A-3a-807. Notification of ballot processes.**

188 (1) As used in this section, "ballot process" includes:

189 (a) signature verification;

190 (b) opening ballots;

191 (c) scanning ballots;

192 (d) adjudicating ballots;

193 (e) replicating damaged or defective ballots; or

194 (f) tabulating votes.

195 (2) A county clerk shall:

196 (a) beginning at least three days before the day on which the county clerk begins
197 mailing ballots for an election, and ending on the first day of the canvass, post on the county
198 clerk's website a schedule of the hours, over the next three days, during which the county clerk
199 plans to conduct one or more ballot processes; and

200 (b) update any changes to the schedule at least 24 hours before the clerk modifies the
201 hours.

202 Section 5. Section **20A-4-104** is amended to read:

203 **20A-4-104. Counting ballots electronically.**

204 (1) (a) Before beginning to count ballots using automatic tabulating equipment, the
205 election officer shall test the automatic tabulating equipment to ensure that it will accurately
206 count the votes cast for all offices and all measures.

207 (b) The election officer shall provide public notice of the time and place of the test:

208 (i) (A) by publishing notice at least 48 hours before the test in a newspaper of general
209 circulation in the county, municipality, or jurisdiction where the equipment is used;

210 (B) at least 10 days before the day of the test, by posting one notice, and at least one
211 additional notice per 2,000 population of the county, municipality, or jurisdiction, in places

212 within the county, municipality, or jurisdiction that are most likely to give notice to the voters
213 in the county, municipality, or jurisdiction, subject to a maximum of 10 notices; or

214 (C) at least 10 days before the day of the test, by mailing notice to each registered voter
215 in the county, municipality, or jurisdiction where the equipment is used;

216 (ii) by posting notice on the Utah Public Notice Website, created in Section
217 [63A-16-601](#), for four weeks before the day of the test; and

218 (iii) if the county, municipality, or jurisdiction has a website, by posting notice on the
219 website for four weeks before the day of the test.

220 (c) The election officer shall conduct the test by processing a preaudited group of
221 ballots.

222 (d) The election officer shall ensure that:

223 (i) a predetermined number of valid votes for each candidate and measure are recorded
224 on the ballots;

225 (ii) for each office, one or more ballots have votes in excess of the number allowed by
226 law in order to test the ability of the automatic tabulating equipment to reject those votes; and

227 (iii) a different number of valid votes are assigned to each candidate for an office, and
228 for and against each measure.

229 (e) If any error is detected, the election officer shall determine the cause of the error
230 and correct it.

231 (f) The election officer shall ensure that:

232 (i) the automatic tabulating equipment produces an errorless count before beginning
233 the actual counting; and

234 (ii) the automatic tabulating equipment passes the same test at the end of the count
235 before the election returns are approved as official.

236 (2) (a) The election officer or the election officer's designee shall supervise and direct
237 all proceedings at the counting center.

238 (b) (i) Proceedings at the counting center are public and may be observed by interested
239 persons.

240 (ii) Only those persons authorized to participate in the count may touch any ballot or
241 return.

242 (c) The election officer shall deputize and administer an oath or affirmation to all

243 persons who are engaged in processing and counting the ballots that they will faithfully
244 perform their assigned duties.

245 (3) (a) If any ballot is damaged or defective so that it cannot properly be counted by the
246 automatic tabulating equipment, the election officer shall ensure that two counting judges
247 jointly:

248 [~~(a)~~] (i) make a true replication of the ballot with an identifying serial number;
249 [~~(b)~~] (ii) substitute the replicated ballot for the damaged or defective ballot;
250 [~~(c)~~] (iii) label the replicated ballot "replicated"; and
251 [~~(d)~~] (iv) record the replicated ballot's serial number on the damaged or defective
252 ballot.

253 (b) The lieutenant governor shall provide to each election officer a standard form on
254 which the election officer shall maintain a log of all replicated ballots, that includes, for each
255 ballot:

256 (i) the serial number described in Subsection (3)(a);
257 (ii) the identification of the individuals who replicated the ballot;
258 (iii) the reason for the replication; and
259 (iv) any other information required by the lieutenant governor.

260 (c) An election officer shall:

261 (i) maintain the log described in Subsection (3)(b) in a complete and legible manner, as
262 ballots are replicated;

263 (ii) at the end of each day during which one or more ballots are replicated, make an
264 electronic copy of the log; and

265 (iii) keep each electronic copy made under Subsection (3)(c)(ii) for at least 22 months.

266 (4) The election officer may:

267 (a) conduct an unofficial count before conducting the official count in order to provide
268 early unofficial returns to the public;

269 (b) release unofficial returns from time to time after the polls close; and

270 (c) report the progress of the count for each candidate during the actual counting of
271 ballots.

272 (5) Beginning on the day after the date of the election, if an election officer releases
273 early unofficial returns or reports the progress of the count for each candidate under Subsection

274 (4), the election officer shall, with each release or report, disclose an estimate of the total
275 number of voted ballots in the election officer's custody that have not yet been counted.

276 (6) The election officer shall review and evaluate the provisional ballot envelopes and
277 prepare any valid provisional ballots for counting as provided in Section [20A-4-107](#).

278 (7) (a) The election officer or the election officer's designee shall:

279 (i) separate, count, and tabulate any ballots containing valid write-in votes; and

280 (ii) complete the standard form provided by the clerk for recording valid write-in votes.

281 (b) In counting the write-in votes, if, by casting a valid write-in vote, a voter has cast
282 more votes for an office than that voter is entitled to vote for that office, the poll workers shall
283 count the valid write-in vote as being the obvious intent of the voter.

284 (8) (a) The election officer shall certify the return printed by the automatic tabulating
285 equipment, to which have been added write-in and absentee votes, as the official return of each
286 voting precinct.

287 (b) Upon completion of the count, the election officer shall make official returns open
288 to the public.

289 (9) If for any reason it becomes impracticable to count all or a part of the ballots with
290 tabulating equipment, the election officer may direct that they be counted manually according
291 to the procedures and requirements of this part.

292 (10) After the count is completed, the election officer shall seal and retain the
293 programs, test materials, and ballots as provided in Section [20A-4-202](#).

294 Section 6. Section **20A-4-105** is amended to read:

295 **20A-4-105. Standards and requirements for evaluating voter's ballot choice.**

296 (1) (a) An election officer shall ensure that when a question arises regarding a vote
297 recorded on a manual ballot, two counting judges jointly adjudicate the ballot, except as
298 otherwise provided in Part 6, Municipal Alternate Voting Methods Pilot Project, in accordance
299 with the requirements of this section.

300 (b) If the counting judges disagree on the disposition of a vote recorded on a ballot that
301 is adjudicated under this section, the counting judges may not count the vote.

302 (c) An election officer shall store adjudicated ballots separately from other ballots to
303 enable a court to review the ballots if the election is challenged in court.

304 (2) Except as provided in Subsection (10), Subsection [20A-3a-204](#)(6), or Part 6,

305 Municipal Alternate Voting Methods Pilot Project, if a voter marks more names than there are
306 individuals to be elected to an office, or if the counting judges cannot determine a voter's
307 choice for an office, the counting judges may not count the voter's vote for that office.

308 (3) Except as otherwise provided in Part 6, Municipal Alternate Voting Methods Pilot
309 Project, the counting judges shall count a defective or incomplete mark on a manual ballot if:

310 (a) the defective or incomplete mark is in the proper place; and

311 (b) there is no other mark or cross on the ballot indicating the voter's intent to vote
312 other than as indicated by the incomplete or defective mark.

313 (4) Except as otherwise provided in Part 6, Municipal Alternate Voting Methods Pilot
314 Project, the counting judges may not reject a ballot marked by the voter because of marks on
315 the ballot other than those marks allowed by this section unless the extraneous marks on a
316 ballot show an intent by an individual to mark the individual's ballot so that the individual's
317 ballot can be identified.

318 (5) (a) In counting the ballots, the counting judges shall give full consideration to the
319 intent of the voter.

320 (b) The counting judges may not invalidate a ballot because of mechanical or technical
321 defects in voting or failure on the part of the voter to follow strictly the rules for balloting
322 required by Chapter 3a, Voting.

323 (6) The counting judges may not reject a ballot because of an error in:

324 (a) stamping or writing an official endorsement; or

325 (b) delivering the wrong ballots to a polling place.

326 (7) The counting judges may not count a manual ballot that does not have the official
327 endorsement by an election officer.

328 (8) The counting judges may not count a ballot proposition vote or candidate vote for
329 which the voter is not legally entitled to vote, as defined in Section [20A-4-107](#).

330 (9) If the counting judges discover that the name of a candidate is misspelled on a
331 ballot, or that the initial letters of a candidate's given name are transposed or omitted in whole
332 or in part on a ballot, the counting judges shall count a voter's vote for the candidate if it is
333 apparent that the voter intended to vote for the candidate.

334 (10) The counting judges shall count a vote for the president and the vice president of
335 any political party as a vote for the presidential electors selected by the political party.

336 (11) Except as otherwise provided in Part 6, Municipal Alternate Voting Methods Pilot
337 Project, in counting the valid write-in votes, if, by casting a valid write-in vote, a voter has cast
338 more votes for an office than that voter is entitled to vote for that office, the counting judges
339 shall count the valid write-in vote as being the obvious intent of the voter.
