LONG TITLE

General Description:

This bill amends provisions related to fees for expungements.

Highlighted Provisions:

This bill:

- ▶ creates sunset dates regarding the suspension of certain expungement fees;
- ▶ suspends fees for the issuance of a certificate of eligibility or a special certificate of eligibility from the Bureau of Criminal Identification for an expungement until June 30, 2023;
- ▶ suspends fees for a petition for expungement until June 30, 2023;
- ▶ creates a reporting requirement for expungement data; and
- ▶ makes technical and conforming changes.

Money Appropriated in this Bill:

This bill appropriates in fiscal year 2023:

- ▶ to General Fund Restricted - Court Security Account, as a one-time appropriation:
 - from the General Fund, One-time, \$62,700;
- ▶ to General Fund Restricted - Children's Legal Defense, as a one-time appropriation:
 - from the General Fund, One-time, \$10,500;
- ▶ to Civil Fees Judges' Retirement Trust Fund, as a one-time appropriation:
 - from the General Fund, One-time, \$31,400; and
- ▶ to Department of Public Safety - Bureau of Criminal Identification -

75 The process for a petition for the expungement of records under this chapter regarding
76 the arrest, investigation, detention, and conviction of a petitioner is as follows:

77 (1) The petitioner shall apply to the bureau for a certificate of eligibility for
78 expungement and pay the application fee established by the department.

79 (2) Once the eligibility process is complete, the bureau shall:

80 (a) notify the petitioner[-]; and

81 (b) if the petitioner is qualified to receive a certificate of eligibility for expungement,
82 issue a certificate of eligibility.

83 ~~[(3) If the petitioner is qualified to receive a certificate of eligibility for expungement,~~
84 ~~the petitioner shall pay the issuance fee established by the department.]~~

85 ~~[(4)]~~ (3) (a) The petitioner shall file the certificate of eligibility with a petition for

117 **77-40-106. Application for certificate of eligibility -- Fees.**

118 (1) (a) A petitioner seeking to obtain an expungement for a criminal record shall apply
119 for a certificate of eligibility from the bureau.

120 (b) A petitioner who intentionally or knowingly provides any false or misleading

121 information to the bureau when applying for a certificate of eligibility is guilty of a class B
122 misdemeanor and subject to prosecution under Section 76-8-504.6.

123 (c) Regardless of whether the petitioner is prosecuted, the bureau may deny a
124 certificate of eligibility to anyone who knowingly provides false information on an application.

125 (2) (a) The bureau shall perform a check of records of governmental agencies,
126 including national criminal data bases, to determine whether a petitioner is eligible to receive a
127 certificate of eligibility under this chapter.

128 (b) For purposes of determining eligibility under this chapter, the bureau may review
129 records of arrest, investigation, detention and conviction that have been previously expunged,
130 regardless of the jurisdiction in which the expungement occurred.

131 (c) If the petitioner meets all of the criteria under Section 77-40-104 or 77-40-105, the
132 bureau shall issue a certificate of eligibility to the petitioner which shall be valid for a period of
133 90 days from the date the certificate is issued.

135 unobtainable, the bureau may issue a special certificate giving determination of eligibility to
136 the court.

137 (3) (a) The bureau shall charge application and issuance fees for a certificate of
138 eligibility or special certificate in accordance with the process in Section 63J-1-504.

139 (b) The application fee shall be paid at the time the petitioner submits an application
140 for a certificate of eligibility to the bureau.

141 (c) If the bureau determines that the issuance of a certificate of eligibility or special
142 certificate is appropriate, the petitioner will be charged an additional fee for the issuance of a
143 certificate of eligibility or special certificate unless Subsection (3)(d) applies.

144 (d) An issuance fee may not be assessed against a petitioner who qualifies for a
145 certificate of eligibility under Section 77-40-104 unless the charges were dismissed pursuant to
146 a plea in abeyance agreement under Title 77, Chapter 2a, Pleas in Abeyance, or a diversion
147 agreement under Title 77, Chapter 2, Prosecution, Screening, and Diversion.

148 (e) Funds generated under this Subsection (3) shall be deposited in the General Fund as
149 a dedicated credit by the department to cover the costs incurred in determining eligibility.

150 (4) The bureau shall provide clear written directions to the petitioner along with a list
151 of agencies known to be affected by an order of expungement.

152 (5) (a) The requirement for a petitioner to pay an issuance fee for a certificate of
153 eligibility or a special certificate of eligibility under Subsection (3) is suspended from May 4,
154 2022, to June 30, 2023.

158 **77-40-107. Petition for expungement -- Prosecutorial responsibility -- Hearing --**
159 **Standard of proof -- Exception.**

160 (1) The petitioner shall file a petition for expungement and, except as provided in
161 Subsection **77-40-103**~~[(5)]~~(4), the certificate of eligibility in the court specified in Section
162 **77-40-103** and deliver a copy of the petition and certificate to the prosecuting agency. If the
163 certificate is filed electronically, the petitioner or the petitioner's attorney shall keep the original
164 certificate until the proceedings are concluded. If the original certificate is filed with the
165 petition, the clerk of the court shall scan it and return it to the petitioner or the petitioner's
166 attorney, who shall keep it until the proceedings are concluded.

167 (2) (a) Upon receipt of a petition for expungement of a conviction or a charge
168 dismissed in accordance with a plea in abeyance, the prosecuting attorney shall provide notice
169 of the expungement request by first-class mail to the victim at the most recent address of record
170 on file.

171 (b) The notice shall:

172 (i) include a copy of the petition, certificate of eligibility, statutes, and rules applicable
173 to the petition;

174 (ii) state that the victim has a right to object to the expungement; and

175 (iii) provide instructions for registering an objection with the court.

176 (3) The prosecuting attorney and the victim, if applicable, may respond to the petition
177 by filing a recommendation or objection with the court within 35 days after receipt of the
178 petition.

179 (4) (a) The court may request a written response to the petition from the Division of
180 Adult Probation and Parole within the Department of Corrections.

181 (b) If requested, the response prepared by the Division of Adult Probation and Parole
182 shall include:

183 (i) the reasons probation was terminated; and

184 (ii) certification that the petitioner has completed all requirements of sentencing and
185 probation or parole.

186 (c) The Division of Adult Probation and Parole shall provide a copy of the response to
187 the petitioner and the prosecuting attorney.

188 (5) The petitioner may respond in writing to any objections filed by the prosecutor or
189 the victim and the response prepared by the Division of Adult Probation and Parole within 14
190 days after receipt.

191 (6) (a) If the court receives an objection concerning the petition from any party, the
192 court shall set a date for a hearing and notify the petitioner and the prosecuting attorney of the
193 date set for the hearing. The prosecuting attorney shall notify the victim of the date set for the
194 hearing.

195 (b) The petitioner, the prosecuting attorney, the victim, and any other person who has
196 relevant information about the petitioner may testify at the hearing.

197 (c) The court shall review the petition, the certificate of eligibility, and any written
198 responses submitted regarding the petition.

199 (7) If no objection is received within 60 days from the date the petition for
200 expungement is filed with the court, the expungement may be granted without a hearing.

201 (8) The court shall issue an order of expungement if the court finds by clear and
202 convincing evidence that:

204 of eligibility are sufficient;

205 (b) the statutory requirements have been met;

219 (f) if an objection is received, the petition for expungement is for a charge dismissed in
220 accordance with a plea in abeyance agreement, and the charge is an offense eligible to be used
221 for enhancement, there is good cause for the court to grant the expungement; and

222 (g) it is not contrary to the interests of the public to grant the expungement.

223 (9) (a) If the court denies a petition described in Subsection (8)(c) because the
224 prosecutor intends to refile charges, the person seeking expungement may again apply for a
225 certificate of eligibility if charges are not refiled within 180 days of the day on which the court
226 denies the petition.

227 (b) A prosecutor who opposes an expungement of a case dismissed without prejudice
228 or without condition shall have a good faith basis for the intention to refile the case.

229 (c) A court shall consider the number of times that good faith basis of intention to
230 refile by the prosecutor is presented to the court in making the court's determination to grant
231 the petition for expungement described in Subsection (8)(c).

232 (10) If the court grants a petition described in Subsection (8)(e), the court shall make
233 the court's findings in a written order.

234 (11) A court may not expunge a conviction of an offense for which a certificate of

238 (1) No later than November 1 of each year, the Administrative Office of the Courts
239 shall submit a written report to the Executive Offices and Criminal Justice Appropriations
240 Subcommittee and the Judiciary Interim Committee regarding expungement data for the
241 preceding fiscal year, including:

242 (a) the number of petitions filed for expungement in the district, justice, and juvenile
243 courts;

244 (b) the number of petitions granted for expungement in the district, justice, and

245 juvenile courts;

246 (c) the number of orders issued for an automatic expungement by the district, justice,
247 and juvenile courts;

248 (d) the total number of individuals for whom at least one automatic expungement order
249 was issued by the district, justice, or juvenile court; and

250 (e) the total number of individuals for whom at least one petition-based expungement
251 order was issued by the district, justice, or juvenile court.

252 (2) No later than November 1 of each year, the bureau shall submit a written report to
253 the Executive Offices and Criminal Justice Appropriations Subcommittee and the Judiciary
254 Interim Committee regarding expungement data for the preceding fiscal year, including:

255 (a) the number of applications for expungement received by the bureau;

256 (b) the number of certificates of eligibility issued by the bureau; and

260 (1) (a) The fee for filing any civil complaint or petition invoking the jurisdiction of a
261 court of record not governed by another subsection is \$375.

262 (b) The fee for filing a complaint or petition is:

263 (i) \$90 if the claim for damages or amount in interpleader exclusive of court costs,
264 interest, and attorney fees is \$2,000 or less;

265 (ii) \$200 if the claim for damages or amount in interpleader exclusive of court costs,
266 interest, and attorney fees is greater than \$2,000 and less than \$10,000;

267 (iii) \$375 if the claim for damages or amount in interpleader is \$10,000 or more;

268 (iv) \$325 if the petition is filed under Title 30, Chapter 3, Divorce, or Title 30, Chapter
269 4, Separate Maintenance;

270 (v) \$35 for a motion for temporary separation order filed under Section [30-3-4.5](#);

271 (vi) \$125 if the petition is for removal from the Sex Offender and Kidnap Offender
272 Registry under Section [77-41-112](#); and

273 (vii) \$35 if the petition is for guardianship and the prospective ward is the biological or
274 adoptive child of the petitioner.

275 (c) The fee for filing a small claims affidavit is:

276 (i) \$60 if the claim for damages or amount in interpleader exclusive of court costs,
277 interest, and attorney fees is \$2,000 or less;

278 (ii) \$100 if the claim for damages or amount in interpleader exclusive of court costs,
279 interest, and attorney fees is greater than \$2,000, but less than \$7,500; and

280 (iii) \$185 if the claim for damages or amount in interpleader exclusive of court costs,
281 interest, and attorney fees is \$7,500 or more.

282 (d) The fee for filing a counter claim, cross claim, complaint in intervention, third party
283 complaint, or other claim for relief against an existing or joined party other than the original
284 complaint or petition is:

285 (i) \$55 if the claim for relief exclusive of court costs, interest, and attorney fees is
286 \$2,000 or less;

287 (ii) \$165 if the claim for relief exclusive of court costs, interest, and attorney fees is
288 greater than \$2,000 and less than \$10,000;

289 (iii) \$170 if the original petition is filed under Subsection (1)(a), the claim for relief is
290 \$10,000 or more, or the party seeks relief other than monetary damages; and

291 (iv) \$130 if the original petition is filed under Title 30, Chapter 3, Divorce, or Title 30,
292 Chapter 4, Separate Maintenance.

293 (e) The fee for filing a small claims counter affidavit is:

294 (i) \$50 if the claim for relief exclusive of court costs, interest, and attorney fees is
295 \$2,000 or less;

296 (ii) \$70 if the claim for relief exclusive of court costs, interest, and attorney fees is
297 greater than \$2,000, but less than \$7,500; and

298 (iii) \$120 if the claim for relief exclusive of court costs, interest, and attorney fees is
299 \$7,500 or more.

300 (f) The fee for depositing funds under Section 57-1-29 when not associated with an
301 action already before the court is determined under Subsection (1)(b) based on the amount
302 deposited.

303 (g) The fee for filing a petition is:

304 (i) \$240 for trial de novo of an adjudication of the justice court or of the small claims
305 department; and

306 (ii) \$80 for an appeal of a municipal administrative determination in accordance with

307 Section [10-3-703.7](#).

308 (h) The fee for filing a notice of appeal, petition for appeal of an interlocutory order, or
309 petition for writ of certiorari is \$240.

310 (i) The fee for filing a petition for expungement is \$150.

311 (j) (i) Fifteen dollars of the fees established by Subsections (1)(a) through (i) shall be
312 allocated to and between the Judges' Contributory Retirement Trust Fund and the Judges'
313 Noncontributory Retirement Trust Fund, as provided in Title 49, Chapter 17, Judges'
314 Contributory Retirement Act, and Title 49, Chapter 18, Judges' Noncontributory Retirement
315 Act.

316 (ii) Four dollars of the fees established by Subsections (1)(a) through (i) shall be
317 allocated by the state treasurer to be deposited into the restricted account, Children's Legal
318 Defense Account, as provided in Section [51-9-408](#).

319 (iii) Three dollars of the fees established under Subsections (1)(a) through (e), (1)(g),
320 and (1)(s) shall be allocated to and deposited with the Dispute Resolution Account as provided
321 in Section [78B-6-209](#).

322 (iv) Thirty dollars of the fees established by Subsections (1)(a), (1)(b)(iii) and (iv),
323 (1)(d)(iii) and (iv), (1)(g)(ii), (1)(h), and (1)(i) shall be allocated by the state treasurer to be

332 50% of the fee for filing an original action seeking the same relief.

333 (m) The fee for filing probate or child custody documents from another state is \$35.

334 (n) (i) The fee for filing an abstract or transcript of judgment, order, or decree of the
335 State Tax Commission is \$30.

336 (ii) The fee for filing an abstract or transcript of judgment of a court of law of this state
337 or a judgment, order, or decree of an administrative agency, commission, board, council, or

338 hearing officer of this state or of its political subdivisions other than the State Tax
339 Commission, is \$50.

340 (o) The fee for filing a judgment by confession without action under Section
341 [78B-5-205](#) is \$35.

342 (p) The fee for filing an award of arbitration for confirmation, modification, or
343 vacation under Title 78B, Chapter 11, Utah Uniform Arbitration Act, that is not part of an
344 action before the court is \$35.

345 (q) The fee for filing a petition or counter-petition to modify a domestic relations order
346 other than a protective order or stalking injunction is \$100.

347 (r) The fee for filing any accounting required by law is:

348 (i) \$15 for an estate valued at \$50,000 or less;

349 (ii) \$30 for an estate valued at \$75,000 or less but more than \$50,000;

350 (iii) \$50 for an estate valued at \$112,000 or less but more than \$75,000;

351 (iv) \$90 for an estate valued at \$168,000 or less but more than \$112,000; and

352 (v) \$175 for an estate valued at more than \$168,000.

353 (s) The fee for filing a demand for a civil jury is \$250.

354 (t) The fee for filing a notice of deposition in this state concerning an action pending in
355 another state under Utah Rules of Civil Procedure, Rule 30 is \$35.

356 (u) The fee for filing documents that require judicial approval but are not part of an
357 action before the court is \$35.

358 (v) The fee for a petition to open a sealed record is \$35.

359 (w) The fee for a writ of replevin, attachment, execution, or garnishment is \$50 in
360 addition to any fee for a complaint or petition.

361 (x) (i) The fee for a petition for authorization for a minor to marry required by Section
362 [30-1-9](#) is \$5.

363 (ii) The fee for a petition for emancipation of a minor provided in Title 80, Chapter 7,
364 Emancipation, is \$50.

365 (y) The fee for a certificate issued under Section [26-2-25](#) is \$8.

366 (z) The fee for a certified copy of a document is \$4 per document plus 50 cents per
367 page.

368 (aa) The fee for an exemplified copy of a document is \$6 per document plus 50 cents

369 per page.

370 (bb) The Judicial Council shall, by rule, establish a schedule of fees for copies of
371 documents and forms and for the search and retrieval of records under Title 63G, Chapter 2,
372 Government Records Access and Management Act. Fees under Subsection (1)(bb) and (cc)
373 shall be credited to the court as a reimbursement of expenditures.

374 (cc) The Judicial Council may, by rule, establish a reasonable fee to allow members of
375 the public to conduct a limited amount of searches on the Xchange database without having to
376 pay a monthly subscription fee.

377 (dd) There is no fee for services or the filing of documents not listed in this section or
378 otherwise provided by law.

379 (ee) Except as provided in this section, all fees collected under this section are paid to
380 the General Fund. Except as provided in this section, all fees shall be paid at the time the clerk
381 accepts the pleading for filing or performs the requested service.

382 (ff) The filing fees under this section may not be charged to the state, the state's
383 agencies, or political subdivisions filing or defending any action. In judgments awarded in
384 favor of the state, its agencies, or political subdivisions, except the Office of Recovery
385 Services, the court shall order the filing fees and collection costs to be paid by the judgment
386 debtor. The sums collected under this Subsection (1)(ff) shall be applied to the fees after credit
387 to the judgment, order, fine, tax, lien, or other penalty and costs permitted by law.

388 (2) (a) (i) From March 17, 1994, until June 30, 1998, the state court administrator shall
389 transfer all revenues representing the difference between the fees in effect after May 2, 1994,
390 and the fees in effect before February 1, 1994, as dedicated credits to the Division of Facilities
391 Construction and Management Capital Projects Fund.

392 (ii) (A) Except as provided in Subsection (2)(a)(ii)(B), the Division of Facilities
393 Construction and Management shall use up to \$3,750,000 of the revenue deposited into the
394 Capital Projects Fund under this Subsection (2)(a) to design and take other actions necessary to
395 initiate the development of a courts complex in Salt Lake City.

396 (B) If the Legislature approves funding for construction of a courts complex in Salt
397 Lake City in the 1995 Annual General Session, the Division of Facilities Construction and
398 Management shall use the revenue deposited into the Capital Projects Fund under this
399 Subsection (2)(a)(ii) to construct a courts complex in Salt Lake City.

400 (C) After the courts complex is completed and all bills connected with its construction
401 have been paid, the Division of Facilities Construction and Management shall use any money
402 remaining in the Capital Projects Fund under this Subsection (2)(a)(ii) to fund the Vernal
403 District Court building.

404 (iii) The Division of Facilities Construction and Management may enter into
405 agreements and make expenditures related to this project before the receipt of revenues
406 provided for under this Subsection (2)(a)(iii).

407 (iv) The Division of Facilities Construction and Management shall:

408 (A) make those expenditures from unexpended and unencumbered building funds
409 already appropriated to the Capital Projects Fund; and

410 (B) reimburse the Capital Projects Fund upon receipt of the revenues provided for
411 under this Subsection (2).

412 (b) After June 30, 1998, the state court administrator shall ensure that all revenues
413 representing the difference between the fees in effect after May 2, 1994, and the fees in effect
414 before February 1, 1994, are transferred to the Division of Finance for deposit in the restricted
415 account.

416 (c) The Division of Finance shall deposit all revenues received from the state court
417 administrator into the restricted account created by this section.

418 (d) (i) From May 1, 1995, until June 30, 1998, the state court administrator shall
419 transfer \$7 of the amount of a fine or bail forfeiture paid for a violation of Title 41, Motor
420 Vehicles, in a court of record to the Division of Facilities Construction and Management
421 Capital Projects Fund. The division of money pursuant to Section 78A-5-110 shall be
422 calculated on the balance of the fine or bail forfeiture paid.

423 (ii) After June 30, 1998, the state court administrator or a municipality shall transfer \$7
424 of the amount of a fine or bail forfeiture paid for a violation of Title 41, Motor Vehicles, in a
425 court of record to the Division of Finance for deposit in the restricted account created by this
426 section. The division of money pursuant to Section 78A-5-110 shall be calculated on the
427 balance of the fine or bail forfeiture paid.

428 (3) (a) There is created within the General Fund a restricted account known as the State
429 Courts Complex Account.

430 (b) The Legislature may appropriate money from the restricted account to the state

431 court administrator for the following purposes only:

432 (i) to repay costs associated with the construction of the court complex that were
433 funded from sources other than revenues provided for under this Subsection (3)(b)(i); and

434 (ii) to cover operations and maintenance costs on the court complex.

435 (4) (a) The requirement of a fee for filing a petition for expungement under Subsection
436 (1)(i) is suspended from May 4, 2022, to June 30, 2023.

437 (b) An individual may not be charged a fee for filing a petition for expungement during
438 the time period described in Subsection (4)(a).

440 **78A-2-301.5. Civil fees for justice courts.**

441 (1) The fee for filing a small claims affidavit is:

442 (a) \$60 if the claim for damages or amount in interpleader exclusive of justice court
443 costs, interest, and attorney fees is \$2,000 or less;

444 (b) \$100 if the claim for damages or amount in interpleader exclusive of justice court
445 costs, interest, and attorney fees is greater than \$2,000, but less than \$7,500; and

446 (c) \$185 if the claim for damages or amount in interpleader exclusive of justice court
447 costs, interest, and attorney fees is \$7,500 or more.

448 (2) The fee for filing a small claims counter affidavit is:

449 (a) \$50 if the claim for relief exclusive of justice court costs, interest, and attorney fees
450 is \$2,000 or less;

451 (b) \$70 if the claim for relief exclusive of justice court costs, interest, and attorney fees
452 is greater than \$2,000, but less than \$7,500; and

453 (c) \$120 if the claim for relief exclusive of justice court costs, interest, and attorney
454 fees is \$7,500 or more.

455 (3) The fee for filing a petition for expungement is \$135.

456 (4) The fee for a petition to open a sealed record is \$35.

457 (5) The fee for a writ of replevin, attachment, execution, or garnishment is \$50 in
458 addition to any fee for a complaint or petition.

459 (6) The fee for filing a notice of appeal to a court of record is \$10. This fee covers all
460 services of the justice court on appeal but does not satisfy the trial de novo filing fee in the
461 court of record.

462 (7) The fee for a certified copy of a document is \$4 per document plus 50 cents per
463 page.

464 (8) The fee for an exemplified copy of a document is \$6 per document plus 50 cents
465 per page.

466 (9) The fee schedule adopted by the Judicial Council for copies of documents and
467 forms and for the search and retrieval of records under Title 63G, Chapter 2, Government
468 Records Access and Management Act, shall apply.

469 (10) There is no fee for services or the filing of documents not listed in this section or
470 otherwise provided by law.

471 (11) The filing fees under this section may not be charged to the state, its agencies, or
472 political subdivisions filing or defending any action. In judgments awarded in favor of the
473 state, its agencies, or political subdivisions, except the Office of Recovery Services, the court
474 shall order the filing fees and collection costs to be paid by the judgment debtor. The sums
475 collected under this Subsection (11) shall be applied to the fees after credit to the judgment,
476 order, fine, tax, lien, or other penalty and costs permitted by law.

477 (12) (a) The requirement of a fee for filing a petition for expungement under
478 Subsection (3) is suspended from May 4, 2022, to June 30, 2023.

479 (b) An individual may not be charged a fee for filing a petition for expungement during
480 the time period described in Subsection (12)(a).
