7 **LONG TITLE**

8 **General Description:**

9 This bill creates the Criminal Justice Data Management Task Force.

10 **Highlighted Provisions:**

11 This bill:

- 12 ▶ creates the Criminal Justice Data Management Task Force;
- 13 ▶ defines membership;
- 14 ▶ sets out the task force's responsibilities; and
- 15 ▶ sets a sunset date.

16 **Money Appropriated in this Bill:**

17 This bill appropriates in fiscal year 2022:

- 18 ▶ to the Commission on Criminal and Juvenile Justice -- CCJJ Commission:
 - 19 • from General Fund, One-time -- \$50,000.

20 This bill appropriates in fiscal year 2023:

- 21 ▶ to the Commission on Criminal and Juvenile Justice -- CCJJ Commission:
 - 22 • from General Fund -- \$170,000.

23 **Other Special Clauses:**

24 This bill provides a special effective date.

31 *Be it enacted by the Legislature of the state of Utah:*

32 Section 1. Section **36-29-109** is enacted to read:

33 **36-29-109. Criminal Justice Data Management Task Force.**

34 (1) As used in this section, "task force" means the Criminal Justice Data Management
35 Task Force created in this section.

36 (2) There is created the Criminal Justice Data Management Task Force consisting of
37 the following members:

38 (a) three members of the Senate appointed by the president of the Senate, no more than
39 two of whom may be from the same political party;

40 (b) three members of the House of Representatives appointed by the speaker of the
41 House of Representatives, no more than two of whom may be from the same political party;
42 and

43 (c) representatives from the following organizations as requested by the executive
44 director of the Commission on Criminal and Juvenile Justice:

45 (i) the Commission on Criminal and Juvenile Justice;

46 (ii) the Office of the Utah Attorney General;

47 (iii) the Judicial Council;

48 (iv) the Statewide Association of Prosecutors;

49 (v) the Department of Corrections;

50 (vi) the Department of Public Safety;

51 (vii) the Utah League of Cities and Towns;

52 (viii) the Utah Association of Counties;

53 (ix) the Utah Chiefs of Police Association;

54 (x) the Utah Sheriffs Association;

55 (xi) the Board of Pardons and Parole;

56 (xii) a representative from a bail bond agency; and
57 (xiii) any other organizations or groups as recommended by the executive director of
58 the Commission on Criminal and Juvenile Justice.

59 (3) (a) The president of the Senate shall designate a member of the Senate appointed
60 under Subsection (2)(a) as a cochair of the task force.

61 (b) The speaker of the House of Representatives shall designate a member of the House
62 of Representatives appointed under Subsection (2)(b) as a cochair of the task force.

63 (4) (a) A majority of the members of the task force present at a meeting constitutes a
64 quorum.

65 (b) The action of a majority of a quorum constitutes an action of the task force.

66 (5) (a) Salaries and expenses of the members of the task force who are legislators shall
67 be paid in accordance with Section [36-2-2](#) and Legislative Joint Rules, Title 5, Chapter 3,
68 Legislator Compensation.

69 (b) A member of the task force who is not a legislator:

70 (i) may not receive compensation for the member's work associated with the task force;
71 and

72 (ii) may receive per diem and reimbursement for travel expenses incurred as a member
73 of the task force at the rates established by the Division of Finance under Sections [63A-3-106](#)
74 and [63A-3-107](#).

75 (6) The Commission on Criminal and Juvenile Justice shall provide staff support to the
76 task force.

77 (7) The task force shall review the state's current criminal justice data collection
78 requirements and make recommendations regarding:

79 (a) possible ways to connect the various records systems used throughout the state so
80 that data can be shared between criminal justice agencies and with policymakers;

81 (b) ways to automate the collection, storage, and dissemination of the data;

82 (c) standardizing the format of data collection and retention; and

83 (d) the collection of data not already required related to criminal justice.

84 (8) On or before November 30, 2022, the task force shall provide a report, including
85 any proposed legislation, to:

86 (a) the Law Enforcement and Criminal Justice Interim Committee; and

87 (b) the Legislative Management Committee.

88 (9) The task force is repealed April 30, 2023.

89 Section 2. Section **63I-2-236** is amended to read:

90 **63I-2-236. Repeal dates -- Title 36.**

91 (1) Section 36-29-107.5 is repealed on November 30, 2023.

92 (2) Section 36-29-109 is repealed April 30, 2023.

93 ~~(2)~~ (3) The following sections regarding the State Flag Task Force are repealed on
94 January 1, 2024:

95 (a) Section 36-29-201;

96 (b) Section 36-29-202; and

98 Section 3. **Appropriation.**

124 The Legislature intends that the Commission on Criminal and Juvenile Justice use this
125 appropriation to fund the position of Data Program Manager.

126 **Section 5. Effective date.**

127 If approved by two-thirds of all the members elected to each house, Section 3 of this
128 bill takes effect upon approval by the governor, or the day following the constitutional time
129 limit of Utah Constitution, Article VII, Section 8, without the governor's signature, or in the
130 case of a veto, the date of veto override.
