3	HR3-3-101. Chair to preserve order and decorum.
4	(1) The chair shall preserve order and decorum during a House committee meeting by:
5	(a) ensuring nothing obstructs a walkway or the view of a meeting attendee;
6	(b) ensuring the meeting is free from any audible or visual disturbance;
7	(c) protecting state property from damage or disarray;
8	(d) prohibiting speech likely to incite or produce imminent lawless action, fighting
9	words, or obscenity; and
0	(e) prohibiting any activity or item that poses a danger to the safety of a meeting
1	attendee.
2	(2) To preserve order and decorum in accordance with Subsection (1), the chair may:
3	(a) prohibit the following:
4	(i) standing, waving, yelling, or clapping;
5	(ii) loud noises;
6	(iii) food or drink, other than water in a closed container;
7	(iv) musical instruments;
8	(v) any item that may require excessive cleanup; or
9	(vi) to the extent necessary to preserve order and decorum, any other item or activity

1	(b) clear the meeting room of one or more individuals;
2	(c) recess the meeting; or
3	(d) request assistance from:
1	(i) the sergeant-at-arms; or
5	(ii) the Utah Highway Patrol.

67	(vii) a noise maker;
