8 **LONG TITLE**

9 **General Description:**

10 This bill repeals the Interventions for Reading Difficulties Program.

11 **Highlighted Provisions:**

12 This bill:

- 13 ▶ repeals the Interventions for Reading Difficulties Program;
- 14 ▶ repeals a sunset date that the repeal renders obsolete; and
- 15 ▶ makes technical and conforming changes.

18 **Other Special Clauses:**

19 This bill provides a special effective date.
