- ▶ provides that the division shall certify the teams, looking to national models for input;~~f~~

Be it enacted by the Legislature of the state of Utah:

Section 1. Section **26B-4-102** is enacted to read:

26B-4-102. Mental health crisis response grant program.

(1) As used in this section:

(a) "Best practice crisis intervention team" means a team of law enforcement officers and mental health professionals certified by the division and operating in accordance with the recommendations of the council.

(b) "Council" means the Mental Health Crisis Intervention Council created in Section 62A-15-1902.

~~(b)~~(c) "Division" means the Division of Integrated Healthcare created in Section 26B-1-204.

(d) "Law enforcement officer" means the same as that term is defined in Section 53-13-103.

~~(c)~~(e) "Local law enforcement agency" means the same as that term is defined in Section 53-13-101.

~~(d)~~(f) "Local mental health authority" means the same as that term is defined in

(2) The division shall establish and administer a grant program for:

~~(b) local mental health authorities to create or expand mobile crisis outreach teams.~~

~~(3) The partnership with mobile crisis outreach teams is a response model that deploys a mental health clinician and a certified peer support specialist in response to an incident where an individual needs assistance and the incident does not involve:~~

(iii) collaborations;
