43	CHAPTER 30. RESIDENTIAL PROPERTY SERVICE AGREEMENTS
44	Part 1. General Provisions
45	<u>57-30-101.</u> Definitions.
46	As used in this chapter:
47	(1) "Common interest community" means the same as that term is defined in Section
48	<u>57-25-102.</u>
49	(2) "Home warranty service contract" means the same as that term is defined in Section
50	<u>31A-6a-101.</u>
51	(3) "Record" means to submit a document to a county recorder for official placement in
52	a public land record.
53	(4) (a) "Residential property service agreement" means, except as provided in
54	Subsection (4)(b), a contract under which a person agrees to provide services in connection
55	with:
56	(i) the purchase or sale of residential real estate; or

57	(ii) the maintenance of residential real estate in preparation for purchase or sale.
58	(b) "Residential property service agreement" does not include:
59	(i) a home warranty service agreement;
60	(ii) an insurance contract;
61	(iii) an option to purchase or right of refusal; or
62	(iv) a maintenance or repair agreement between an owner of real property within a
63	common interest community and a homeowners' association or other similar organization.
64	(5) "Residential real estate" means real property located in the state that is:
65	(a) used primarily for a personal, family, or household purpose; and
66	(b) contains fewer than five dwelling units.

71	(1) (a) A residential property service agreement may not:
72	(i) allow the services to be provided under the agreement to begin more than one year
73	after the day on which the residential property service agreement is signed by all parties;
74	(ii) indicate that the residential property service agreement:
75	(A) runs with the land;
76	(B) is binding on a future owner of an interest in the residential real estate that is the
77	subject of the residential property service agreement; or
78	(C) creates a lien, encumbrance, or other real property security interest; or
79	(iii) allow for the assignment of the right to provide the services without notice to and
80	agreement by the owner of the residential real estate that is the subject of the residential
81	property service agreement.
82	(b) A residential property service agreement that violates Subsection (1)(a) is void.
83	(2) (a) A person may not record or cause to be recorded:
84	(i) a void residential property service agreement; or
85	(ii) a notice or memorandum concerning a void residential property service agreement
86	(b) A county recorder may refuse to accept a document described in Subsection (2)(a)

89	in the residential real estate that is the subject of the void residential property service agreement
90	may file a petition with a court of competent jurisdiction to recover actual damages from the

249	(2) An associate broker or sales agent may receive valuable consideration for the
250	performance of an act specified in this chapter from a person other than the principal broker
251	with whom the associate broker or sales agent is affiliated if:
252	(a) the valuable consideration is paid with a payment instrument prepared by a title
253	insurance agent; and
254	[(b) the title insurance agent provides the payment instrument to the principal broker;]

272	The following acts are unlawful and grounds for disciplinary action for a person
273	licensed or required to be licensed under this chapter:

274	(1) (a) making a substantial misrepresentation, including in a licensure statement;
275	(b) making an intentional misrepresentation;
276	(c) pursuing a continued and flagrant course of misrepresentation;
277	(d) making a false representation or promise through an agent, sales agent, advertising,
278	or otherwise; or
279	(e) making a false representation or promise of a character likely to influence,
280	persuade, or induce;
281	(2) acting for more than one party in a transaction without the informed written consent
282	of the parties;
283	(3) (a) acting as an associate broker or sales agent while not affiliated with a principal
284	broker;
285	(b) representing or attempting to represent a principal broker other than the principal

287	(c) representing as sales agent or having a contractual relationship similar to that of
