	(1) (a) A contiguous, unincorporated area that is contiguous to a municipality may be
ann	exed to the municipality as provided in this part.
	(b) Except as provided in Subsection (1)(c), an unincorporated area may not be
ann	exed to a municipality unless:

28	(i) the unincorporated area is a contiguous area;
29	(ii) the unincorporated area is contiguous to the municipality;

- (6) (a) As used in this Subsection (6), "airport" means an area that the Federal Aviation Administration has, by a record of decision, approved for the construction or operation of a Class I, II, or III commercial service airport, as designated by the Federal Aviation Administration in 14 C.F.R. Part 139.
- (b) A municipality may not annex an unincorporated area within 5,000 feet of the center line of any runway of an airport operated or to be constructed and operated by another municipality unless the legislative body of the other municipality adopts a resolution consenting to the annexation.
- (c) A municipality that operates or intends to construct and operate an airport and does not adopt a resolution consenting to the annexation of an area described in Subsection (6)(b) may not deny an annexation petition proposing the annexation of that same area to that municipality.
- (7) (a) As used in this Subsection (7), "project area" means a project area as defined in Section 63H-1-102 that is in a project area plan as defined in Section 63H-1-102 adopted by the Military Installation Development Authority under Title 63H, Chapter 1, Military

91	(b) A municipality may not annex an unincorporated area located within a project area

142	changed.
143	(g) (i) This subsection does not apply to an annexation approved before May 3, 2023,
144	unless the annexation is not yet incorporated into a municipality's master zoning plan.
145	(ii) If an annexation approved before May 3, 2023, is not incorporated into a
146	municipality's master zoning before July 31, 2023, a municipality shall consult with the
147	military authority to ensure zoning is compatible with military land use.
