94	an important role with water supply users to encourage the optimized use of water such as
95	through localized messaging, rebate programs, or other activities.
96	Section 2. Appropriation.
97	The following sums of money are appropriated for the fiscal year beginning July 1,
98	2023, and ending June 30, 2024. These are additions to amounts previously appropriated for
99	fiscal year 2024. Under the terms and conditions of Title 63J, Chapter 1, Budgetary Procedures
100	Act, the Legislature appropriates the following sums of money from the funds or accounts
