Be it enacted by the Legislature of the state of Utah:

Section 1. Section **9-8-906** is enacted to read:

9-8-906. Utah Archaeological and Historic Sites ~~{Assistance Fund.~~

~~— (1) As used in this section:~~

~~— (a) "Fund" means the Utah Archaeological and Historic Sites Assistance Fund, created in Subsection (2)(a).~~

~~— (b) "Office" means the State Historic Preservation Office.~~

~~— (2) (a) There is created an expendable special revenue fund known as the Utah Archaeological and Historic Sites Assistance Fund.~~

~~— (b) The fund shall assist private landowners with identifying and protecting archaeological resources on the private landowners' land.~~

~~— (c) The cost of administering the fund shall be paid from money in the fund.~~

~~— (3) **Grant Program.**~~

(1) The office shall:

(a) administer the money contained in the ~~{fund}~~ grant program; and

(b) select qualified recipients in accordance with Subsection (~~{4}~~2).

(~~{4}~~2) The office may distribute the ~~{funds}~~ money from the grant program to a private landowner:

(a) that applies to the office, in a manner prescribed by the office, to receive all or part of the money contained in the ~~{fund}~~ grant program; and

(b) for identifying and protecting archaeological resources on the landowner's property, if the private landowner contributes an amount of money equal to or greater than the amount of money the landowner receives from the ~~{fund}~~ grant program.

Section 2. **Appropriation.**
