8	General Description:
9	This bill amends provisions of the Utah Juvenile Code related to child welfare.
10	Highlighted Provisions:
11	This bill:
12	defines terms;
13	 modifies the requirements for a member of the oversight team managing the
14	psychotropic medication oversight pilot program for children in foster care;
15	 allows the Division of Child and Family Services to establish citizen review panels;
16	 describes the duties of a citizen review panel and authorizes a citizen review panel
17	to access certain records and information to fulfill the panel's duties;
18	 establishes the Child Welfare Improvement Council as a citizen review panel;
19	 provides that, while an interstate compact request is ordered or pending, the court
20	may not finalize a non-relative placement unless the court makes certain
21	considerations;
22	 modifies the preferential consideration granted to a relative for placement of a child;
23	removes a limit on the preferential consideration granted to a natural parent after
24	120 days following a shelter hearing;
25	 amends the circumstances under which the division is required to notify former



26	foster parents when a child reenters temporary custody or the custody of the division;
27	 removes a provision related to the primary permanency plan for a child who is three
28	years old or younger;
29	 repeals a provision related to the development of a volunteer network by the
30	Division of Child and Family Services; and
31	 makes technical and conforming changes.

56	(1) As used in this section, "psychotropic medication" means medication prescribed to

5/	affect or after thought processes, mood, or behavior, including antipsychotic, antidepressant,
58	anxiolytic, or behavior medication.
59	(2) The division shall, through contract with the Department of Health and Human
60	Services, establish and operate a psychotropic medication oversight pilot program for children
61	in foster care to ensure that foster children are being prescribed psychotropic medication
62	consistent with the foster children's needs.
63	(3) The division shall establish an oversight team to manage the psychotropic
64	medication oversight program, composed of at least the following individuals:
65	(a) an advanced practice registered nurse, as defined in Section 58-31b-102, [employed
66	by] contracted with the Department of Health and Human Services; and
67	(b) a child psychiatrist.
68	(4) The oversight team shall monitor foster children:
69	(a) six years old or younger who are being prescribed one or more psychotropic
70	medications; and
71	(b) seven years old or older who are being prescribed two or more psychotropic
72	medications.
73	(5) The oversight team shall, upon request, be given information or records related to
74	the foster child's health care history, including psychotropic medication history and mental and
75	behavioral health history, from:
76	(a) the foster child's current or past caseworker;
77	(b) the foster child; or
78	(c) the foster child's:
79	(i) current or past health care provider;
80	(ii) natural parents; or
81	(iii) foster parents.
82	(6) The oversight team may review and monitor the following information about a
83	foster child:
84	(a) the foster child's history;
85	(b) the foster child's health care, including psychotropic medication history and mental
86	or behavioral health history;
87	(c) whether there are less invasive treatment options available to meet the foster child's

89	(d) the dosage or dosage range and appropriateness of the foster child's psychotropic

91	(e) the short-term or long-term risks associated with the use of the foster child's

94	(7) (a) The oversight team may make recommendations to the foster child's health care
95	providers concerning the foster child's psychotropic medication or the foster child's mental or
96	behavioral health.
97	(b) The oversight team shall provide the recommendations made in Subsection (7)(a)
98	to the foster child's parent or guardian after discussing the recommendations with the foster
99	child's current health care providers.
100	(8) The division may adopt administrative rules in accordance with Title 63G, Chapter
101	3, Utah Administrative Rulemaking Act, necessary to administer this section.

103	regarding the psychotropic medication oversight pilot program by October 1 of each even

108	(1) The division shall develop and implement a Management Information System that
109	meets the requirements of this section and the requirements of federal law and regulation.

176	person who is currently receiving services from the specific contract provider or Indian tribe.

179	(d) (i) The Office of Guardian Ad Litem may only access:
180	(A) the information that is entered into the Management Information System on or after

(1) (a) There is established the Child Welfare Improvement Council composed of no

more than 25 members who are appointed by the division.

213	expire, the division shall appoint each new member or reappointed member to a four-year
214	term.]
215	[(c) Notwithstanding the requirements of Subsection (1)(b), the division shall, at the
216	time of appointment or reappointment, adjust the length of terms to ensure that the terms of
217	council members are staggered so that approximately half of the council is appointed every two
218	years.]
219	[(d) The council shall have geographic, economic, gender, cultural, and philosophical
220	diversity.]

222	appoint the replacement for the unexpired term.]
223	[(2) The council shall elect a chairperson from the council's membership at least

292	(c) emergency placement under Subsection 80-2a-202(5);
293	(d) as an alternative to removal of the child, a parent enters a domestic violence shelter

345	(6) If the child is in protective custody, the division shall report to the juvenile court:
346	(a) the reason why the child was removed from the parent's or guardian's custody;
347	(b) any services provided to the child and the child's family in an effort to prevent
348	removal;
349	(c) the need, if any, for continued shelter;
350	(d) the available services that could facilitate the return of the child to the custody of
351	the child's parent or guardian; and
352	(e) subject to Subsections 80-3-302(7)(c) [through (e)] and (d), whether any relatives of
353	the child or friends of the child's parents may be able and willing to accept temporary
354	placement of the child.
355	(7) The juvenile court shall consider all relevant evidence provided by an individual or
356	entity authorized to present relevant evidence under this section.
357	(8) (a) If necessary to protect the child, preserve the rights of a party, or for other good
358	cause shown, the juvenile court may grant no more than one continuance, not to exceed five
359	judicial days.
360	(b) A juvenile court shall honor, as nearly as practicable, the request by a parent or
361	guardian for a continuance under Subsection (8)(a).
362	(c) Notwithstanding Subsection (8)(a), if the division fails to provide the notice
363	described in Subsection (2) within the time described in Subsection (3), the juvenile court may
364	grant the request of a parent or guardian for a continuance, not to exceed five judicial days.
365	(9) (a) If the child is in protective custody, the juvenile court shall order that the child
366	be returned to the custody of the parent or guardian unless the juvenile court finds, by a

367	preponderance of the evidence, consistent with the protections and requirements provided in
368	Subsection 80-2a-201(1), that any one of the following exists:
369	(i) subject to Subsection (9)(b)(i), there is a serious danger to the physical health or
370	safety of the child and the child's physical health or safety may not be protected without
371	removing the child from the custody of the child's parent;
372	(ii) (A) the child is suffering emotional damage that results in a serious impairment in
373	the child's growth, development, behavior, or psychological functioning;
374	(B) the parent or guardian is unwilling or unable to make reasonable changes that
375	would sufficiently prevent future damage; and
376	(C) there are no reasonable means available by which the child's emotional health may
377	be protected without removing the child from the custody of the child's parent or guardian;
378	(iii) there is a substantial risk that the child will suffer abuse or neglect if the child is
379	not removed from the custody of the child's parent or guardian;
380	(iv) subject to Subsection (9)(b)(ii), the child or a minor residing in the same
381	household has been, or is considered to be at substantial risk of being, physically abused,
382	sexually abused, or sexually exploited by:
383	(A) a parent or guardian;
384	(B) a member of the parent's household or the guardian's household; or
385	(C) an individual known to the parent or guardian;
386	(v) the parent or guardian is unwilling to have physical custody of the child;
387	(vi) the parent or guardian is unable to have physical custody of the child;
388	(vii) the child is without any provision for the child's support;
389	(viii) a parent who is incarcerated or institutionalized has not or cannot arrange for safe
390	and appropriate care for the child;
391	(ix) (A) a relative or other adult custodian with whom the child is left by the parent or
392	guardian is unwilling or unable to provide care or support for the child;
393	(B) the whereabouts of the parent or guardian are unknown; and
394	(C) reasonable efforts to locate the parent or guardian are unsuccessful;
395	(x) subject to Subsection 80-1-102(58)(b)(i) and Sections 80-3-109 and 80-3-304, the
396	child is in immediate need of medical care;
397	(xi) (A) the physical environment or the fact that the child is left unattended beyond a

398	reasonable period of time poses a threat to the child's health or safety; and
399	(B) the parent or guardian is unwilling or unable to make reasonable changes that
400	would remove the threat;
401	(xii) (A) the child or a minor residing in the same household has been neglected; and
402	(B) the parent or guardian is unwilling or unable to make reasonable changes that
403	would prevent the neglect;
404	(xiii) the parent, guardian, or an adult residing in the same household as the parent or
405	guardian, is charged or arrested pursuant to Title 58, Chapter 37d, Clandestine Drug Lab Act,
406	and any clandestine laboratory operation was located in the residence or on the property where
407	the child resided;
408	(xiv) (A) the child's welfare is substantially endangered; and
409	(B) the parent or guardian is unwilling or unable to make reasonable changes that
410	would remove the danger; or
411	(xv) the child's natural parent:
412	(A) intentionally, knowingly, or recklessly causes the death of another parent of the
413	child;
414	(B) is identified by a law enforcement agency as the primary suspect in an investigation
415	for intentionally, knowingly, or recklessly causing the death of another parent of the child; or
416	(C) is being prosecuted for or has been convicted of intentionally, knowingly, or
417	recklessly causing the death of another parent of the child.
418	(b) (i) Prima facie evidence of the finding described in Subsection (9)(a)(i) is
419	established if:
420	(A) a court previously adjudicated that the child suffered abuse, neglect, or dependency
421	involving the parent; and
422	(B) a subsequent incident of abuse, neglect, or dependency involving the parent occurs.
423	(ii) For purposes of Subsection (9)(a)(iv), if the juvenile court finds that the parent
424	knowingly allowed the child to be in the physical care of an individual after the parent received
425	actual notice that the individual physically abused, sexually abused, or sexually exploited the
426	child, that fact is prima facie evidence that there is a substantial risk that the child will be
427	physically abused, sexually abused, or sexually exploited.
428	(10) (a) (i) The juvenile court shall make a determination on the record as to whether

reasonable efforts were made to prevent or eliminate the need for removal of the child from the child's home and whether there are available services that would prevent the need for continued removal.

- (ii) If the juvenile court finds that the child can be safely returned to the custody of the child's parent or guardian through the provision of the services described in Subsection (10)(a)(i), the juvenile court shall place the child with the child's parent or guardian and order that the services be provided by the division.
- (b) In accordance with federal law, the juvenile court shall consider the child's health, safety, and welfare as the paramount concern when making the determination described in Subsection (10)(a), and in ordering and providing the services described in Subsection (10)(a).
- (11) If the division's first contact with the family occurred during an emergency situation in which the child could not safely remain at home, the juvenile court shall make a finding that any lack of preplacement preventive efforts, as described in Section 80-2a-302, was appropriate.
- (12) In cases where sexual abuse, sexual exploitation, abandonment, severe abuse, or severe neglect are involved, the juvenile court and the division do not have any duty to make reasonable efforts or to, in any other way, attempt to maintain a child in the child's home, return a child to the child's home, provide reunification services, or attempt to rehabilitate the offending parent or parents.
- (13) The juvenile court may not order continued removal of a child solely on the basis of educational neglect, truancy, or failure to comply with a court order to attend school.
