47	(b) "Standard, guideline, or policy" means a requirement or measurement of
48	performance imposed by an applicable charter school authorizer on two or more charter
49	schools authorized by the applicable charter school authorizer.
50	(2) (a) An applicable charter school authorizer shall adopt a procedure for the
51	imposition of a standard, guideline, or policy that is substantially similar to the rulemaking
52	procedure under Title 63G, Chapter 3, Utah Administrative Rulemaking Act, including
53	procedures for notice and receipt of public comment.
54	(b) An applicable charter school authorizer may not impose a standard, guideline, or
55	policy unless the applicable charter school authorizer follows the procedure adopted under
56	Subsection (2)(a).
57	(3) A standard, guideline, or policy imposed on or after July 1, 2023, by an applicable

charter school authorizer is not valid if the applicable charter school authorizer does not follow

59 the procedures adopted under Subsection (2)(a) in imposing the standard, guideline, or policy.
