8	General Description:
9	This bill enacts a public safety officer scholarship program for high school students
10	entering into a law enforcement career.
11	Highlighted Provisions:
12	This bill:

14	<ul><li>creates a public safety officer scholarship program for high school graduates who:</li></ul>
15	<ul> <li>enroll in a law enforcement agency cadet program;</li> </ul>

17	<ul> <li>after Peace Officer Standards and Training (POST) certification, commit to a</li> </ul>
18	peace officer career of a certain minimum duration;
19	<ul><li>establishes application and work requirement processes;</li></ul>
20	<ul> <li>allows for institutions of higher education to determine participation in the program;</li> </ul>
21	<ul> <li>requires a scholarship recipient to report certification and employment statuses to</li> </ul>
22	the Utah Board of Higher Education (board);
23	<ul> <li>requires the POST Division to report employment status changes to the board;</li> </ul>
24	<ul> <li>provides for repayment of scholarship funds in the case of a failure to meet program</li> </ul>

46	Section 1. Section <b>53-6-209</b> is amended to read:
47	53-6-209. Termination of employment Change of status form.
48	(1) When a peace officer's employment terminates, the employing agency shall submit
49	a change of status form noting the termination of the peace officer to the division.
50	(2) The change of status form shall:
51	(a) be completed and submitted within 30 days [of the peace officer's termination date]
52	after the day on which the peace officer's employment terminates;
53	(b) identify the circumstances of the peace officer's status change by indicating that the
54	peace officer has resigned, retired, terminated, transferred, is deceased, or that the peace
55	officer's name has changed;
56	(c) indicate the effective date of action; and

57	(d) indicate the name of the new employer, if the status change is due to a transfer.
58	(3) If a peace officer's employment terminates during an open internal investigation
59	regarding that peace officer and involving an alleged violation of Subsection 53-6-211(1), the
60	employing agency shall:
61	(a) notify the division of the investigation in accordance with Subsection 53-6-211(6)
62	within 30 days [of the peace officer's termination date] after the day on which the peace
63	officer's employment terminates and
64	(b) provide a reasonable estimated date of completion for the investigation.
65	(4) (a) If an employing agency receives credible allegations and opens an internal
66	investigation within two years after [a peace officer's employment has been terminated] the day
67	on which a peace officer's employment terminates, the employing agency shall:
68	(i) notify the division within 30 days [of the date of the opening of the] after the day on
69	which the employing agency opens the investigation; and
70	(ii) provide a reasonable estimated date of completion for the investigation.
71	(b) If the allegations described in Subsection (4)(a) involve alleged violations of
72	Subsection 53-6-211(1), the agency shall report the allegations to the division in accordance
73	with Subsection 53-6-211(6), regardless of whether [or not] the employing agency opens an
74	internal investigation.
75	(5) Any person or agency who intentionally falsifies, misrepresents, or fails to give
76	notice of the change of status of a peace officer is liable to the division for any damages that
77	[may be sustained by] the failure to make the notification[-] causes. The division shall provide
78	the change of status form described in this section to the Utah Board of Higher Education
79	within 30 days after the day on which the division receives a notice of termination if the
80	relevant peace officer has received a Public Safety Officer Scholarship as described in Section
81	<u>53B-8-112.5.</u>
82	Section 2. Section <b>53B-8-112</b> is amended to read:
83	53B-8-112. Public Safety Officer Career Advancement Grant Program.
84	(1) [The] This section creates the Public Safety Officer Career Advancement Grant
85	Program [is created].
86	(2) Subject to legislative appropriations and Subsection [(6)] (7), the board shall award
87	a grant to an applicant who:

88 (a) is a certified peace officer, currently employed by a law enforcement agency within 89 the state; and (b) is seeking a post-secondary degree in the area of criminal justice from a 90 91 [credit-granting higher education institution] degree-granting institution of higher education 92 within the state system of higher education, described in Section 53B-1-102. 93 (3) (a) Subject to Subsection (3)(b), the board may award a qualified applicant up to 94 the cost of tuition and fees. 95 (b) A grant award under Subsection (3)(a) is limited to: 96 (i) a maximum of \$5,000 each academic year; and 97 (ii) a maximum of four academic years. 98 (4) The board shall design the program to [use a packaging approach that ensures] 99 ensure that institutions combine loans, grants, employment, and family and individual 100 contributions toward financing the cost of attendance. (5) Notwithstanding Subsection (4), the board may not award a scholarship described 101 in Section 53B-8-112.5 to an applicant receiving a grant under this section. 102 103 [(5)] (6) (a) The board shall make rules in accordance with Title 63G, Chapter 3, Utah 104 Administrative Rulemaking Act, to: 105 (i) set deadlines for receiving grant applications and supporting documentation; and 106 (ii) establish the application process and an appeal process for the Public Safety Officer 107 Career Advancement Grant Program. 129	(c) "Program" means the Public Safety Officer Scholarship Program that this section
130	<u>creates.</u>
131	(2) This section creates the Public Safety Officer Scholarship Program.
132	(3) (a) Subject to legislative appropriations, the board shall award a scholarship to a
133	qualified applicant who:
134	(i) is a high school graduate;
135	(ii) submits an application to the board with a copy of the student's high school
136	diploma;
137	(iii) when eligible, enrolls in a basic training course at a state certified academy as
138	defined in Section 53-6-202;
139	(iv) is enrolled in a qualifying post-secondary degree program from a degree-granting
140	institution of higher education within the state system of higher education, described in Section
141	<u>53B-1-102; and</u>
142	(v) commits to working as a peace officer for no less than five years after the day on
143	which POST certifies the scholarship recipient.
144	(b) For purposes of Subsection (3)(a)(iv), a degree-granting institution shall determine:
145	(i) the institution's participation in the program; and
146	(ii) the degrees the institution will grant, including criminal justice, police
147	administration, criminology, social sciences, and other related disciplines.
148	(4) (a) The board shall determine the amount of a scholarship award, ensuring that the
149	amount does not exceed the combined cost of tuition, fees, and required textbooks.

150	(b) A scholarship award described in Subsection (4)(a) is limited to:
151	(i) POST training and certification in accordance with Title 53, Chapter 6, Peace
152	Officer Standards and Training Act; and
153	(ii) a maximum of four academic years in a post-secondary degree program.
154	(5) The board shall design the scholarship program to ensure that participating
155	institutions combine state or federal loans or grants, internships, student employment, and
156	family and individual contributions toward financing the cost of attendance.
157	(6) A scholarship recipient shall:
158	(a) notify the board of the scholarship recipient's POST certification within 15 days
159	after the day on which POST certifies the scholarship recipient;
160	(b) submit verification of the scholarship recipient's employment to the board within 15
161	days after the day on which the scholarship recipient is employed as a peace officer, including:
162	(i) the employer's name, address, and telephone number;
163	(ii) the date of the scholarship recipient's hiring; and
164	(iii) the scholarship recipient's job title; and
165	(c) notify the board within 15 days after the day on which the employer terminates the
166	scholarship recipient.
167	(7) A scholarship recipient shall repay to the board the full amount of the scholarship
168	award that the scholarship recipient received under the program, including money paid for
169	tuition, fees, and required textbooks, if the scholarship recipient fails to:
170	(a) meet the requirements for POST certification as described in Title 53, Chapter 6,
171	Part 2, Peace Officer Training and Certification Act;
172	(b) work as a peace officer for less than five years after the day on which POST
173	certifies the scholarship recipient; or
174	(c) subject to Subsection (3), earn a degree within four contiguous academic years
175	beginning on the day on which the scholarship recipient enrolls in a post-secondary degree
176	program.
177	(8) (a) The board shall make rules, in accordance with Title 63G, Chapter 3, Utah
178	Administrative Rulemaking Act, to:
179	(i) set deadlines for receiving scholarship applications and supporting documentation;
180	(ii) establish an application process and appeal process for the program;

181	(iii) establish policies and procedures for cancellation or repayment of scholarship
182	awards if the scholarship recipient fails to meet the requirements under this section;
183	(iv) collaborate with POST and other law enforcement and correction agencies to
184	provide high school students information on law enforcement careers; and
185	(v) notify POST when a student receives a scholarship under the program.
186	(b) The board shall include a disclosure on all applications and materials related to the
187	program that the amount of the awarded scholarship may be subject to funding availability or
188	reduction in accordance with Subsection (9).
189	(9) If an appropriation under this section is insufficient to cover the costs associated
190	with the program, the board may:
191	(a) reduce the amount of a scholarship award; and
192	(b) distribute scholarship awards on a pro rata basis to all eligible applicants who
193	submitted a complete application before the application deadline.
194	Section 4. Section <b>53B-10-106</b> is amended to read:
195	53B-10-106. Pathways development.
196	(1) The board shall develop and implement a plan that creates clear educational
197	pathways:
198	(a) from a technical college described in Subsection 53B-1-102(1)(b) to an institution;
199	[ <del>and</del> ]
200	(b) in course work leading to a qualifying [degree] job or a qualifying [job] degree as
201	described in Section 53B-10-203[-]; and
202	(c) for high schools that offer criminal justice or protective services pathways
203	programs, including information on:
204	(i) available concurrent enrollment classes in subjects described in Section
205	53B-8-112.5; and
206	(ii) scholarship opportunities for careers as peace officers as defined in Section
207	<u>53B-8c-102.</u>
208	(2) The plan shall maximize efficiencies in transferring [earned] earned credit and help
209	align academic programs with workforce needs.
210	(3) In accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act, the
211	board may make rules necessary to establish a plan described in this section.

212	Section 5. Appropriation.
213	The following sums of money are appropriated for the fiscal year beginning July 1,
214	2023, and ending June 30, 2024. These are additions to amounts previously appropriated for
