**LONG TITLE**

**General Description:**

This bill renames the Traumatic Brain Injury Fund.

**Highlighted Provisions:**

- ▶ renames the Traumatic Brain Injury Fund as the "Brain Injury Fund"; and
- ▶ makes technical changes.

29 Section 1. Section **26-50-102** is amended to read:

30 **26-50-102. Definitions.**

31 As used in this chapter:

32 (1) "Committee" means the advisory committee created by the executive director  
33 pursuant to Section **26-50-202**.

34 (2) "Fund" means the [~~Traumatic~~] Brain Injury Fund created in Section **26-50-201**.

35 Section 2. Section **26-50-201** is amended to read:

36 **26-50-201. Brain Injury Fund.**

37 (1) There is created an expendable special revenue fund [~~entitled the Traumatic~~]  
38 known as the Brain Injury Fund.

39 (2) The fund shall consist of:

40 (a) gifts, grants, donations, or any other conveyance of money that may be made to the  
41 fund from private sources; and

42 (b) additional amounts as appropriated by the Legislature.

43 (3) The fund shall be administered by the executive director.

44 (4) Fund money may be used to:

45 (a) educate the general public and professionals regarding understanding, treatment,  
46 and prevention of [~~traumatic~~] brain injury;

47 (b) provide access to evaluations and coordinate short-term care to assist an individual  
48 in identifying services or support needs, resources, and benefits for which the individual may  
49 be eligible;

50 (c) develop and support an information and referral system for persons with a  
51 [~~traumatic~~] brain injury and their families; and

52 (d) provide grants to persons or organizations to provide the services described in  
53 Subsections (4)(a), (b), and (c).

54 (5) Not less than 50% of the fund shall be used each fiscal year to directly assist  
55 individuals who meet the qualifications described in Subsection (6).

56 (6) An individual who receives services either paid for from the fund, or through an

57 organization under contract with the fund, shall:

58 (a) be a resident of Utah;

59 (b) have been diagnosed by a qualified professional as having a [traumatic] brain injury  
60 which results in impairment of cognitive or physical function; and

61 (c) have a need that can be met within the requirements of this chapter.

62 (7) The fund may not duplicate any services or support mechanisms being provided to  
63 an individual by any other government or private agency.

64 (8) All actual and necessary operating expenses for the committee and staff shall be  
65 paid by the fund.

66 (9) The fund may not be used for medical treatment, long-term care, or acute care.

67 Section 3. Section **26-50-202** is amended to read:

68 **26-50-202. Brain Injury Advisory Committee -- Membership -- Time limit.**

69 (1) On or after July 1 of each year, the executive director may create a [Traumatic]  
70 Brain Injury Advisory Committee of not more than nine members.

71 (2) The committee shall be composed of members of the community who are familiar  
72 with [traumatic] brain injury, its causes, diagnosis, treatment, rehabilitation, and support  
73 services, including:

74 (a) persons with a [traumatic] brain injury;

75 (b) family members of a person with a [traumatic] brain injury;

76 (c) representatives of an association which advocates for persons with [traumatic] brain  
77 injuries;

78 (d) specialists in a profession that works with brain injury patients; and

79 (e) department representatives.

80 (3) The department shall provide staff support to the committee.

81 (4) (a) If a vacancy occurs in the committee membership for any reason, a replacement  
82 may be appointed for the unexpired term.

83 (b) The committee shall elect a chairperson from the membership.

84 (c) A majority of the committee constitutes a quorum at any meeting, and, if a quorum  
85 exists, the action of the majority of members present shall be the action of the committee.

86 (d) The committee may adopt bylaws governing the committee's activities.

87 (e) A committee member may be removed by the executive director:

88 (i) if the member is unable or unwilling to carry out the member's assigned  
89 responsibilities; or

90 (ii) for good cause.

91 (5) The committee shall comply with the procedures and requirements of:

92 (a) Title 52, Chapter 4, Open and Public Meetings Act; and

93 (b) Title 63G, Chapter 2, Government Records Access and Management Act.

94 (6) A member may not receive compensation or benefits for the member's service, but,  
95 at the executive director's discretion, may receive per diem and travel expenses in accordance  
96 with:

97 (a) Section 63A-3-106;

98 (b) Section 63A-3-107; and

99 (c) rules made by the Division of Finance pursuant to Sections 63A-3-106 and  
100 63A-3-107.

101 (7) Not later than November 30 of each year the committee shall provide a written  
102 report summarizing the activities of the committee to the executive director of the department.

103 (8) The committee shall cease to exist on December 31 of each year, unless the  
104 executive director determines it necessary to continue.
