The Education Committee recommends **H.B. 427**, PUBLIC EDUCATION CURRICULUM REQUIREMENTS, by Representative T. Jimenez, be replaced and reports a favorable recommendation on **1st Sub. H.B. 427**, INDIVIDUAL FREEDOM IN PUBLIC EDUCATION with the following amendments:

- 1. Page 1, Line 19:
