Be it enacted by the Legislature of the state of Utah:			
Section 1. Section 36-28-102 is amended to read:			
36-28-102 . Veterans and Military Affairs Commission Creation			
Membership Chairs Terms Per diem and expenses.			
(1) There is created the Veterans and Military Affairs Commission.			
(2) The commission membership is composed of [19] 18 permanent members, but may not			
exceed [24] 23 members, and is as follows:			
(a) five legislative members to be appointed as follows:			

(i) three members from the House of Representatives, appointed by the speaker of the

House of Representatives, no more than two of whom may be from the same

30		(ii) two members from the Senate, appointed by the president of the Senate, no more
31		than one of whom may be from the same political party;
32		(b) the executive director of the Department of Veterans and Military Affairs or the
33		director's designee;

35		(d) the executive director of the Department of Workforce Services or the director's
36		designee;
37		(e) the executive director of the Department of Health and Human Services or the
38		director's designee;
39		[(f) the executive director of the Department of Human Services or the director's
40		designee;]
41		[(g)] <u>(f)</u> the adjutant general of the Utah National Guard or the adjutant general's
42		designee;
43		[(h)] (g) the Guard and Reserve Transition Assistance Advisor;
44		[(i)] (h) a member of the Utah Board of Higher Education or that member's designee;
45		[(j)] (i) three representatives of veteran service organizations recommended by the
46		Veterans Advisory Council and confirmed by the commission;
47		[(k)] (j) one member of the Executive Committee of the Utah Defense Alliance;
48		[(1)] (k) one military affairs representative from a chamber of commerce member,
49		appointed by the Utah State Chamber of Commerce; and
50		[(m)] (1) a representative from the Veterans Health Administration.
51	(3)	The commission may appoint by majority vote of the entire commission up to five pro
52		tempore members, representing:
53		(a) state or local government agencies;
54		(b) interest groups concerned with veterans issues; or
55		(c) the general public.
56	(4)	(a) The president of the Senate shall designate a member of the Senate appointed
57		under Subsection (2)(a) as a cochair of the commission.
58		(b) The speaker of the House of Representatives shall designate a member of the House
59		of Representatives appointed under Subsection (2)(a) as a cochair of the commission.
60	(5)	A majority of the members of the commission shall constitute a quorum. The action of
61		a majority of a quorum constitutes the action of the commission.
62	(6)	The term for each pro tempore member appointed in accordance with Subsection (3)

shall be two years from July 1 of the year of appointment. A pro tempore member may not serve more than three terms.

- originally appointed. A person appointed to fill a vacancy under Subsection (6) serves
- the remaining unexpired term of the member being replaced. If the remaining unexpired
- term is less than six months, the newly appointed member shall be reappointed on July
- 1. The time served until July 1 is not counted in the restriction set forth in Subsection (6).
