Be it enacted by the Legislature of the state of Utah:

Section 1. Section **26B-4-321.1** is enacted to read:

26B-4-321.1. Disclosure of vaccination compensation.

<u>{If}(1)</u> As used in this section, "incentive compensation" means any payment or other benefit that:

- (a) serves as a reward to a health care provider { is subject to receive additional compensation};
- (b) the health care provider may only earn, in whole or {payment} in {exchange} part, for administering a vaccine { or vaccines}; and
 - (c) is in addition to the health care provider's regular compensation, salary, or wage.
- (2) If a health care provider, as defined in Section 76B-3-403, is a candidate to receive incentive compensation for the administration of a vaccine to a patient, the health care provider shall {, before} make a disclosure to the patient:
 - (a) prior to administering the vaccine {, disclose};
 - (b) in writing, including:
 - (i) by email;
 - (ii) as part of the patient's contract for services;
- (iii) as part of other written communications or set of disclosures made to the patient for the patient's guardian the nature and amount of the additional compensation the health care provider is subject to receive; or
 - (iv) as a separate disclosure;
 - (c) showing the total value of incentive compensation; and
 - (d) identifying the individual or entity obligated to pay the incentive compensation.

Section 2. Effective date.

This bill takes effect on May 1, $\frac{2024}{2025}$.
