3   **LONG TITLE**

4   **General Description:**

5       This bill modifies provisions relating to meetings held by the State Tax Commission (the  
6   commission).

7   **Highlighted Provisions:**

8       This bill:

9       ▸ makes permanent the authority for the commission:

10           • to make amendments to commission publications that are not substantive without  
11 holding a public meeting; and

12           • to hold a meeting that is not open to the public to provide guidance to the  
13 commission's employees on the interpretation and application of a law administered by the  
14 commission; and

15       ▸ repeals a requirement that the commission provide a report to the Revenue and Taxation  
16 Interim Committee containing information on commission meetings that were not open to the  
17 public and that were held during the previous year to provide guidance to commission  
18 employees.
