	(1) As used in this section:
	(a) "District" means a water conservancy district, as that term is defined in Section
<u>7</u>	<u>'3-10-32.</u>
	(b) "Division" means the Division of Water Resources.
	(c) "Great Salt Lake basin" means the area within:
	(i) the surveyed meander line of the Great Salt Lake;
	(ii) the drainage areas of the Bear River or the Bear Rivers tributaries;
	(iii) the drainage areas of Bear Lake or Bear Lakes tributaries;
	(iv) the drainage areas of the Weber River or the Weber Rivers tributaries;
	(v) the drainage areas of the Jordan River or the Jordan Rivers tributaries;
	(vi) the drainage areas of Utah Lake or Utah Lakes tributaries;
	(vii) other water drainages lying between the Bear River and the Jordan River that are
<u>tı</u>	ributary to the Great Salt Lake and not included in the drainage areas described in Subsections
(1)(c)(ii) through (vi); and
	(viii) the drainage area of Tooele Valley.
	(d) (i) Except as provided in Subsection (1)(d)(ii), "lawn or turf" means nonagricultural

58	(e) "New construction landscaping incentive program" means a program administered
59	by a district that pays a qualifying applicant a financial incentive to install water efficient
60	landscaping in a project area.
61	(f) "Owner" means a person who:
62	(i) contracts with a person who is licensed as a contractor or is exempt from licensure
63	under Title 58, Chapter 55, Utah Construction Trades Licensing Act, for the construction on an
64	owner-occupied residence upon real property that the person:
65	(A) owns; or
66	(B) purchases after the person enters into a contract described in this Subsection
67	(1)(f)(i) and before completion of the owner-occupied residence;
68	(ii) contracts with a real estate developer to buy a residence upon completion of the
69	construction on the owner-occupied residence; or
70	(iii) purchases a residence from a real estate developer after completion of the
71	construction on the owner-occupied residence.
72	(g) "Program guidelines" means guidelines adopted by a district for the district's new
73	construction landscaping incentive program.
74	(h) "Project area" means the area of residential property in which a qualifying applicant
75	installs water efficient landscaping.
76	(i) "Qualifying applicant" means a person who is:
77	(i) an owner; or
78	(ii) a real estate developer.
79	(j) "Real estate developer" means a person having an ownership interest in real
80	property who:
81	(i) contracts with a person who is licensed as a contractor or is exempt from licensure
82	under Title 58, Chapter 55, Utah Construction Trades Licensing Act, for the construction of a
83	residence that is offered for sale to the public; or
84	(ii) is a licensed contractor under Title 58, Chapter 55, Utah Construction Trades
85	Licensing Act, who engages in the construction of a residence that is offered for sale to the
86	public.
87	(k) "Residential property" means the real property on which one of the following is

88	constructed:
89	(i) single family detached housing, including single family detached housing with an
90	accessory dwelling unit; or
91	(ii) a duplex or twin home.
92	(2) For residential property within the Great Salt Lake basin, the division may:
93	(a) award a grant under Subsection (3) to a district to fund a financial incentive
94	provided through a new construction landscaping incentive program administered by the
95	district; and
96	(b) provide an incentive under Subsection (4) in an area without a new construction
97	landscaping incentive program to a qualifying applicant to install water efficient landscaping in
98	a project area.
99	(3) (a) (i) A district may obtain a grant from the division to help fund a financial
100	incentive provided to a qualifying applicant through a new construction landscaping incentive
101	program administered by the district.
102	(ii) Both the award and use of a grant under this Subsection (3) are subject to
103	Subsections (3)(b), (c), and (d).
104	(b) To obtain a grant, a district shall:
105	(i) initiate and operate a new construction landscaping incentive program;
106	(ii) limit the disbursement of grant money in the district's new construction landscaping
107	incentive program to qualifying applicants that satisfy the minimum requirements of
108	Subsections (4)(c) and (d) and:
109	(A) rules made by the division under Subsection (5)(b); or
110	(B) program guidelines approved by the division under Subsection (3)(f);
111	(iii) use the grant exclusively to fund financial incentives provided to a qualifying
112	applicant that installs water efficient landscaping in a project area in the district's new
113	construction landscaping incentive program;
114	(iv) provide matching funds for the district's new construction landscaping incentive
115	program in an amount provided in rules made by the division under Subsection (5) from
116	sources other than the grant money the district receives under this section;
117	(v) file an application with the division that:
118	(A) describes the district's new construction landscaping incentive program, including

119	verification that the new construction landscaping incentive program can and shall implement
120	the minimum requirements of Subsections (4)(c) and (d) and either rules made by the division
121	under Subsection (5)(b) or program guidelines approved by the division under Subsection
122	(3)(f);
123	(B) includes a copy of the program guidelines governing the district's new construction
124	landscaping incentive program;
125	(C) if the district wants to be subject to program guidelines in lieu of division rules
126	made under Subsection (5)(b), requests that the division approve the district's program
127	guidelines under Subsection (3)(f); and
128	(D) provides additional information requested by the division; and
129	(vi) enter into a contract with the division that requires the district to:
130	(A) verify that qualifying applicants comply with and landscaping projects proposed,
131	undertaken, and completed by qualifying applicants under the district's new construction
132	landscaping incentive program satisfy the requirements in this Subsection (3) and any contract
133	before using grant money for a financial incentive;
134	(B) agree not to use grant money for a financial incentive in any landscaping project
135	that fails to satisfy the requirements of this Subsection (3) and either rules made by the division
136	or program guidelines approved by the division under Subsection (3)(f);
137	(C) submit to the division quarterly reports on funding status; and
138	(D) prepare and submit an annual accounting to the division on the use of grant money
139	for financial incentives in the district's new construction landscaping incentive program.
140	(c) (i) Upon expenditure of 70% of the grant money awarded to a district and an
141	accounting on the use of that grant money, a district may apply for additional grant money in
142	accordance with Subsection (3)(b).
143	(ii) The division may award a district an additional grant based on:
144	(A) the availability of grant money;
145	(B) the priority or importance of the grant proposal in relation to availability of grant
146	money, the district's new construction landscaping incentive program under this Subsection (3),
147	other new construction landscaping incentive program grant requests, and regional needs and
148	goals;
149	(C) the effectiveness of the district's new construction landscaping incentive program

150	in incentivizing qualified applicants to install water efficient landscaping;
151	(D) the district's previous compliance with this Subsection (3) and contract terms and
152	conditions; and
153	(E) any matter bearing on the district's ability to responsibly handle and disburse grant
154	money consistent with this Subsection (3) and contract terms and conditions.
155	(d) A district awarded grant money under this Subsection (3) may not use grant money
156	to pay an incentive that exceeds the maximum amounts established by the division by rule
157	under Subsection (5)(c).
158	(e) Nothing in this section prohibits a district from expending non-grant money,
159	including matching funds, under the district's new construction landscaping incentive program
160	<u>to:</u>
161	(i) assist an applicant that does not satisfy Subsection (4)(c) or (d); or
162	(ii) provide an incentive that exceeds a maximum amount established by the division
163	for grant money under Subsection (3)(d).
164	(f) The division may approve a request from a district under Subsection (3)(b)(v)(C) to
165	use program guidelines in lieu of rules made by the division under Subsection (5)(b) if the
166	division determines that the district's program guidelines will:
167	(i) result in at least as much water use savings as rules made under Subsection (5)(b);
168	<u>and</u>
169	(ii) accomplish the same objectives as rules made under Subsection (5)(b).
170	(4) (a) In an area without a new construction landscaping incentive program, the
171	division may provide an incentive to a qualifying applicant to install water efficient
172	landscaping in a project area.
173	(b) (i) If the division provides an incentive under this Subsection (4), the division shall
174	provide the incentive in the order that an application for the incentive is filed.
175	(ii) The division may terminate an application if the division determines that the
176	qualifying applicant has not completed the project within 12 months of the date on which the
177	qualifying applicant files the application for the incentive.
178	(c) To be eligible for an incentive under this Subsection (4):
179	(i) the residential property where the project area is located is within:
180	(A) a municipality that implements regional-based water efficiency standards

101	established by the division under Subsection 75-10-57(3)(d); or
182	(B) an unincorporated area of a county that implements regional-based water efficiency
183	standards established by the division under Subsection 73-10-37(5)(d);
184	(ii) the qualifying applicant shall at the time the qualifying applicant applies for the
185	incentive demonstrate that:
186	(A) the construction on the residential property is new;
187	(B) lawn or turf has not been installed on the project area; and
188	(C) water efficient landscaping is to be installed on the project area; and
189	(iii) the qualifying applicant shall agree to comply with Subsection (4)(f).
190	(d) A qualifying applicant may not receive an incentive under this section if the
191	qualifying applicant has previously received an incentive under this section for the same project
192	<u>area.</u>
193	(e) The amount of an incentive paid to a qualifying applicant under this Subsection (4)
194	may not exceed:
195	(i) the maximum amount established by the division in rule, as provided in Subsection
196	(5) for each square foot of water efficient landscaping installed in the project area; or
197	(ii) the maximum aggregate amount for the residential property established by the
198	division in rule as provided in Subsection (5).
199	(f) (i) If a qualifying applicant is not the owner, the qualifying application shall:
200	(A) require the owner of the residential property to maintain water efficient
201	landscaping and a drip irrigation system installed in the project area and not install lawn or turf
202	or overhead spray irrigation in the project area; or
203	(B) return to the division or to a district the payments received for installation of water
204	efficient landscaping in the project area.
205	(ii) If a qualifying applicant is the owner, the owner shall:
206	(A) maintain water efficient landscaping and a drip irrigation system and not install
207	lawn or turf or overhead spray irrigation in the project area; or
208	(B) return to the division or to a district the payments received for installation of water
209	efficient landscaping in the project area.
210	(5) The division shall make rules, in accordance with Title 63G, Chapter 3, Utah
211	Administrative Rulemaking Act:

212	(a) establishing the process by which:
213	(i) a district obtains a grant under Subsection (3); or
214	(ii) a qualifying applicant applies for and obtains an incentive under Subsection (4);
215	(b) defining what constitutes:
216	(i) water efficient landscaping, including what irrigation is used after installation of
217	water efficient landscaping; and
218	(ii) new construction;
219	(c) establishing for funding under this section:
220	(i) the maximum incentive allowable for each square foot of installed water efficient
221	landscaping within a project area from grant money or money provided to a qualified applicant
222	under Subsection (4); and
223	(ii) a maximum aggregate incentive from grant money or money provided to a
224	qualified applicant under Subsection (4); and
225	(d) establishing the amount of matching funds, which may include labor or other
226	services in lieu of money, a district is required to provide to receive a grant under this section.
227	Section 3. FY 2025 Appropriation.
228	The following sums of money are appropriated for the fiscal year beginning July 1,
229	2024, and ending June 30, 2025. These are additions to amounts previously appropriated for
230	fiscal year 2025.
231	Subsection 3(a). Operating and Capital Budgets.
232	Under the terms and conditions of Title 63J, Chapter 1, Budgetary Procedures Act, the
233	Legislature appropriates the following sums of money from the funds or accounts indicated for
234	the use and support of the government of the state of Utah.
235	ITEM 1 To Department of Natural Resources - Water Resources
236	From General Fund, One-time \$1,000,000
237	Schedule of Programs:
238	Planning \$1,000,000
239	The Legislature intends that this appropriation be nonlapsing.
240	Section 4. Effective date.
