Be it enacted by the Legislature of the state of Utah:
Section 1. Section <b>53F-5-222</b> is enacted to read:
53F-5-222. Strategic Tiered Engagement for Positive Schooling Pilot Program.
(1) As used in this section:
(a) "Evidence-based" means a program, policy, or initiative that is grounded in
empirical data and scientifically supported.
(b) "LEA" means:
(i) a school district; or
(ii) a charter school.
(c) "Microcredential" means a short, competency-based recognition that allows an
educator to demonstrate mastery in a particular area.
(d) "Multi-tiered systems of support" means a proactive and preventative framework
that integrates data and instruction to maximize student achievement and support a student's
behavior needs.
(e) "Strategic Tiered Engagement for Positive Schooling Pilot Program" or "program"
means the pilot program created in Subsection (2).
(2) There is created a three-year pilot program known as the Strategic Tiered
Engagement for Positive Schooling Pilot Program to provide funding to LEAs to design and
implement school-wide systems of proactive, evidence-based supports to improve student
behavior and reduce discipline incidents using multi-tiered systems of support.
(3) The state board shall:
(a) in accordance with this section and subject to legislative appropriations, award a
grant to a participating LEA;
(b) in selecting participating LEAs, prioritize LEAs that:
(i) emphasize evidence-based practices; and
(ii) effectively demonstrate need and existing ability to implement school-wide

60	(c) strive to select participating LEAs:
